RESOLUTION NO. 05

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 005, SERIES OF 2016 AUTHORIZING SUPPLEMENTAL BUDGET NO. 005 OF THE GENERAL FUND OF THE MUNICIPALITY OF BUENAVISTA, PROVINCE OF GUIMARAS OPERATIVE IN PART AND INOPERATIVE IN SO FAR AS THE APPROPRIATION ON THE GRANT OF CNA INCENTIVE

WHEREAS, Appropriation Ordinance No. 005, Series of 2016 of the Municipality of Buenavista authorizing Supplemental Budget No. 005 for the General Fund involving an appropriation of One Million Seven Hundred Sixty Thousand One Hundred Twenty Pesos (₱1,760,120.00) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative in part as of the date fixed in the Appropriation Ordinance and in operative in so far as the appropriation on the grant of the CNA Incentive in the amount of One Million Six Hundred Ninety Five Thousand Pesos (₱1,695,000.00) being sourced out of savings of Personal Services which is not in accordance with Budget Circular No. 2016-7, dated December 1, 2016 re: Guidelines on the Grant of CNA Incentive for FY 2016;

THE 8TH SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:






