RESOLUTION DECLARING ORDINANCE NO. 2016-005 OF THE MUNICIPALITY OF JORDAN ENTITLED: "AN ORDINANCE CREATING A MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE TO BE CALLED AS JORDAN MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE UNDER THE OFFICE OF THE MUNICIPAL MAYOR AND THE POSITIONS ON THE SAID OFFICE, DETERMINING THEIR POWERS, DUTIES AND FUNCTIONS" AS OPERATIVE AND WITHIN THE POWER OF THAT SANGGUNIAN TO ENACT
