**RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 2016-06, AUTHORIZING SUPPLEMENTAL BUDGET NO. 06, CALENDAR YEAR 2016 OF THE GENERAL FUND OF THE MUNICIPALITY OF SAN LORENZO, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS**

WHEREAS, Appropriation Ordinance No. 2016-06 of the Municipality of San Lorenzo authorizing its Supplemental Budget No. 06, Calendar Year 2016 for the General Fund involving an appropriation of One Million Three Hundred Ninety Four Thousand Four Hundred Seventy Six Pesos and Eighty Eight Centavos (₱1,394,476.88) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of Hon. David G. Gano, duly seconded by Hon. Aurelio G. Tionado and Hon. Ma. Sheila G. Gange;

THE 8<sup>TH</sup> SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2016-06 authorizing Supplemental Budget No. 06, Calendar Year 2016 of the Municipality of San Lorenzo, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 2016-06 subject to the following condition:

1. The grant of Collective Negotiations Agreement (CNA) Incentive shall be subject to the provisions of Budget Circular No. 2016-7 dated December 1, 2016 of the Department of Budget and Management.


RESOLVED FURTHER, to require the Municipality of San Lorenzo to comply with the herein conditions and notify this body of the action taken thereon.

RESOLVED STILL FURTHER, to inform the Municipality of San Lorenzo that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law.


RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of San Lorenzo for information.
