**RESOLUTION AUTHORIZING GOV. SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF GUIMARAS THE MEMORANDUM OF AGREEMENT WITH THE FAMILY DIAGNOSTIC CENTER FOR THE PROVISION OF CT SCAN**

WHEREAS, the Honorable Governor, in his letter dated 24 January 2017, requested for an authority to sign for and in behalf of the Provincial Government of Guimaras the Memorandum of Agreement with the Family Diagnostic Center for the provision of CT Scan to patients of the DCGNPH;

WHEREAS, after a thorough deliberation with the presence of Dr. Bobby J. Yoro, Chief of Hospital, the Honorable Body deemed it proper to grant the request;

NOW, THEREFORE, on motion of Hon. Josefina G. de la Cruz, duly seconded by Hon. Cyril C. Beltran, Hon. David G. Gano, Hon. Cresene P. Chavez, Jr., Hon. Diosdado G. Gonzaga, and Hon. Ma. Sheila G. Gange;

THE 8<sup>TH</sup> SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to authorize Gov. Samuel T. Gumarin, MD, MPH to sign for and in behalf of the Provincial Government of Guimaras, the following:

***MEMORANDUM OF AGREEMENT***

***KNOW ALL MEN BY THESE PRESENTS:***

*This Memorandum of Agreement is entered into by and between Dr. Catalino Gallego Nava Provincial Hospital, San Miguel, Jordan, Guimaras, represented by Hon. Samuel T. Gumarin, MD, MPH, Governor, province of Guimaras, herein referred to as First party; and Erwin G. Young of legal age, Filipino with office address at Family Diagnostic Center, J and B3 Building, Quezon St., Iloilo City, Philippines, hereinafter referred to as the Second Party.*

WITNESSETH

WHEREAS, the Second Party is the owner of Family Diagnostic Center which provides CT Scan available for patients of the First Party;

WHEREAS, the Second Party accepts the proposal offered by the First Party that the Second Party shall provide the CT Scan to the patients of the First Party as maybe scheduled during its business hours, without prejudice to the availment of the First party of other diagnostic centers in Iloilo City or anywhere else;

NOW THEREFORE, for and in consideration of the foregoing premises setforth, the parties have hereby agreed to the following terms and conditions:

1. The First Party hereby agrees to allow the Second Party to provide his services to the patients of the First Party;
2. The agreement shall remain in force for a period effective January 25, 2017 until January 25, 2018 and shall be renewable at the option of either party;
3. Anyone of the parties, who decides to pre-terminate this contract, shall give the other party sixty (60) days written notice prior to termination;
4. Violation of any of the terms and conditions of the contract shall be grounds for termination of this contract.
5. The Processing of payment for PHIC-NBB patients shall commence immediately after the issuance of Statement of Account by the Second Party to the First Party and payment shall be done on a monthly basis or within thirty days period.


For PHIC Non-NBB patients, the fee shall be paid by the patient directly to the Family Diagnostic Center based on the guidelines of the availment of CT Scan.
