#### RESOLUTION NO. 26

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 007, SERIES OF 2016, AUTHORIZING SUPPLEMENTAL BUDGET NO. 006 OF THE GENERAL FUND OF THE MUNICIPALITY OF BUENAVISTA, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 007, Series of 2016 of the Municipality of Buenavista authorizing its Supplemental Budget No. 006 for the General Fund involving an appropriation of Five Hundred Nine Thousand Four Hundred Eleven Pesos and Fifty Four Centavos (₱509,411.54) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of Hon. Cyril C. Beltran, Vice Chairperson, Committee on Appropriations, duly seconded by Hon. Dan Elby C. Habaña and Hon. Ramon N. Ortiz;

# THE 8<sup>TH</sup> SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 007, Series of 2016 authorizing Supplemental Budget No. 006 of the Municipality of Buenavista, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 007, Series of 2016 subject to the following condition:

1. The grant of Magna Carta Benefits to Public Health Workers (PHWs) shall be subject to the provisions of Joint Circular No. 1 s. 2016 dated July 15, 2016.

RESOLVED FURTHER, to require the Municipality of Buenavista to comply with the herein conditions and notify this body of the action taken thereon.

RESOLVED STILL FURTHER, to inform the Municipality of Buenavista that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law.

RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of Buenavista for information.
