**RESOLUTION NO. 33**

**RESOLUTION AUTHORIZING GOV. SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF GUIMARAS THE SERVICE AGREEMENT WITH MR. REYNALDO A. OTIC IN RELATION TO REO BROTHERS BAND**

WHEREAS, the Honorable Governor, in his letter dated 10 February 2017 has requested for an authority to sign for and in behalf of the Provincial Government of Guimaras the Service Agreement with Mr. Reynaldo A. Otic, Talent Manager of REO Brothers Band;

WHEREAS, in order to add color and entertainment to the 24<sup>th</sup> Manggahan Festival and 25<sup>th</sup> Anniversary of the province, the Provincial Government of Guimaras will engage the services of the REO Brothers Band on May 18, 2017;

WHEREAS, finding the Service Agreement to be in order, this Honorable Body interposes no objection to the request for authority;

NOW, THEREFORE, on motion of Hon. David G. Gano, unanimously seconded.

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to authorize Gov. Samuel T. Gumarin, MD, MPH, to sign for and in behalf of the Provincial Government of Guimaras, the following:

**SERVICE AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS:

This Service Agreement is entered into this \_\_\_\_ day of \_\_\_\_ 2017 at the Provincial Capitol, Province of Guimaras by and between:

The Provincial Government of Guimaras, a Local Government Unit established under existing laws of the Republic of the Philippines, with principal address at the Provincial Capitol, Brgy. San Miguel, Jordan, Guimaras, represented herein by the Provincial Governor, the **HON. SAMUEL T. GUMARIN, MD, MPH** hereinafter referred to as the **FIRST PARTY**;

-and-

**REYNALDO A. OTIC**, a Talent Manager under Philippine Laws of legal age, Filipino and a resident of 33 Pantabangan St., Napocor Village, Tandang Sora, Quezon City hereinafter referred to as the **SECOND PARTY**;

WITNESSETH

**WHEREAS**, the Province of Guimaras will celebrate the Manggahan Festival in the Month of May 2017 and will have its LGU Night on May 18, 2017;

**WHEREAS**, in the celebration of such Festival, amusement and entertainment is necessary in order that the constituents in the Province of Guimaras who will be participating in such Festival shall enjoy the same;

**NOW THEREFORE**, for and in consideration of the foregoing premises, the parties hereto have agreed to enter into this Service Agreement under the following terms and conditions:

**1.0 The FIRST PARTY shall:**

- 1.1 Engage the services of the **SECOND PARTY** to bring the **REO BROTHERS BAND** in Guimaras to perform during the LGU Night;
- 1.2 Pay the talent fee of **REO BROTHERS BAND** in the amount of **ONE HUNDRED SEVENTY THOUSAND PESOS (₱170,000.00) Net of Tax** (50% upon signing, 50% on the day of the event before the performance starts;
 

₱85,000.00	-	down payment upon signing
₱85,000.00	-	full payment on May 18, 2017 before the performance starts
- 1.3 Pay for the travelling expenses (round trip airfare for 8 persons with 10kgs baggage each, terminal fee, inland transportation to and from Guimaras), meals and accommodation of the **SECOND PARTY**;
- 1.4 Provide the following:
  - Stage/Performance venue
  - Professional lights & Sound System with full Band Set-up (3 Guitars amplifiers, 1 Keyboard amplifiers, 5 floor Monitors)
  - Drum set kit
  - 4 Vocal microphones with stand
  - Holding area (dressing room)
  - Food and drinks (10 pax)
- 1.5 Pay the full contract price of the **SECOND PARTY** as if the engagement has been fulfilled and completed in the event of this agreement is cancelled through no fault of the **SECOND PARTY**.

**2.0 The SECOND PARTY shall:**

- 2.1 Undertakes that **REO BROTHERS BAND** will perform for one and a half (1½ ) hours during the LGU Night on May 18, 2017 at the Food Court Area, San Miguel, Jordan, Guimaras at 8:00 in the evening;
- 2.2 Provide 3 guitars and 1 keyboard;

- 2.3 Conscientiously and punctually adhere to the agreed schedule;
  - 2.4 Refund in full the payments received by the SECOND PARTY to the FIRST PARTY in event that the REO BROTHERS BAND failed to perform; and
  - 2.5 Not accept any other engagements which may be in conflict with this agreement.
- 3.0 **BOTH PARTIES** shall reset to another mutually agreeable date in case of postponement due to force majeure.
- 4.0 **Modification/Amendment and Effectivity**
- 4.1 Any amendment or modification in this agreement shall be translated in writing signed by both parties and shall form part of this agreement; and
  - 4.2 The term of this agreement shall take effect immediately upon the date of signing of the **Service Agreement**.


