RESOLUTION NO. 34

RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 271, SERIES OF 2016 OF THE MUNICIPALITY OF BUENAVISTA ENTITLED: "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 211, SERIES OF 2009, ARTICLE IV, SECTION 6 (2) AGRICULTURAL DEVELOPMENT ZONE (2.2) ADZ 1.1 CROP AREAS PRINCIPALLY DEVOTED TO PERMANENT TREE PLANTATIONS SUCH AS ORCHARDS, AGROFORESTRY AREAS AND TIMBER TREE PLANTATIONS INCLUDING PRIVATELY OWNED LOTS WITH SLOPES RANGING FROM 18% TO 30% THAT HAVE A NATURALLY GROWN COVER OF TREES, SHRUBS AND VINES FOR THE COLLECTION OF MINOR FOREST PRODUCTS FOR DOMESTIC CONSUMPTION, FOR HANDICRAFTS AND SIMILAR USES FOR RE-CLASSIFICATION" AS VALID, OPERATIVE AND WITHIN THE POWERS OF THAT SANGGUNIAN TO LEGISLATE

WHEREAS, for review of this Honorable Body is Municipal Ordinance No. 271, Series of 2016 of the Municipality of Buenavista entitled: "An Ordinance amending Municipal Ordinance No. 211, Series of 2009, Article IV, Section 6 (2) agricultural development zone (2.2) ADZ 1.1 crop areas principally devoted to permanent tree plantations such as orchards, agroforestry areas and timber tree plantations including privately owned lots with slopes ranging from 18% to 30% that have a naturally grown cover of trees, shrubs and vines for the collection of minor forest products for domestic consumption, for handicrafts and similar uses for reclassification";

WHEREAS, the Committee on Housing and Land Utilization to where the said ordinance was referred, rendered a committee report which was adopted by the Honorable Body in its regular session of even date, recommending that Ordinance No. 271 be declared valid, operative and within the powers of that sanggunian to legislate;

NOW, THEREFORE, on motion of Hon. Dan Elby C. Habaña, unanimously seconded;

THE 8TH SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Municipal Ordinance No. 271, Series of 2016 of the Municipality of Buenavista entitled: "An Ordinance amending Municipal Ordinance No. 211, series of 2009, Article IV, Section 6 (2) agricultural development zone (2.2) ADZ 1.1 crop areas principally devoted to permanent tree plantations such as orchards, agro-forestry areas and timber tree plantations including privately owned lots with slopes ranging from 18% to 30% that have a naturally grown cover of trees, shrubs and vines for the collection of minor forest products for domestic consumption, for handicrafts and similar uses for re-classification" as valid, operative and within the powers of that sanggunian to enact.
