RESOLVED, to approve the 2018 Annual Gender and Development (GAD) Plan and Budget of the Province of Guimaras;


RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, GAD Focal person and all other concerned offices for information and appropriate action.


