**RESOLUTION NO. 36**

**RESOLUTION REQUESTING HONORABLE GOVERNOR SAMUEL T. GUMARIN, MD, MPH, FOR THE CREATION OF THE INFORMATION AND SERVICE DELIVERY NETWORK (ISDN) FOR ADOLESCENT HEALTH AND DEVELOPMENT IN THE PROVINCE OF GUIMARAS**

WHEREAS, the Adolescent Health and Youth Development Program has become a priority concern of the provincial government due to the increasing number of cases of teenage pregnancy and teenage birth delivery in the province;

WHEREAS, from 2011 to 2015 there is a total of 429 teenage pregnancies occurring to 10-19 year old adolescent;

WHEREAS, there are also problems established during adolescence stage such as intentional and unintentional injuries, sexual and reproductive health problems, substance use and abuse, mental and nutritional health problems, endemic and chronic diseases as well as suicide;

WHEREAS, addressing these critical concerns affecting young people entails the close collaboration and collective action from all stakeholders such as the Provincial Social Welfare Development Office, the Provincial Health Office, PNP, DepEd with their respective department heads or duly authorized representative, civil society organizations particularly those providing services for young people's concerns, faith-based organizations and the private sector as members of the Team of the Information Service Delivery Network (ISDN) for Adolescent Health and Development;

WHEREAS, with the establishment of the Information Service Delivery Network there is that shared vision, goals and objectives, pooling and sharing of resources comprehensive and holistic services, efficient monitoring and evaluation system and greater effectiveness of programs and projects for adolescence;

WHEREAS, the establishment of Information and Service Delivery Network (ISDN) for Adolescent Health and Development in the province will link information and service delivery interventions for adolescent and youth-related needs and to foster partnership, well-coordinated, multi-sectoral and interagency and comprehensive provision of health, welfare and development interventions for young people in Guimaras which is deemed necessary to address these pressing issues and eventually reduce teenage pregnancy, HIV, AIDS and other sexual and non-sexual behaviors;

NOW, THEREFORE, on motion of Hon. Josefina G. de la Cruz, unanimously seconded;


THE 8<sup>TH</sup> SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:
