RESOLUTION NO. 41

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 11, SERIES OF 2016, AUTHORIZING THE ANNUAL EXECUTIVE BUDGET, FISCAL YEAR 2017 OF THE MUNICIPALITY OF NUEVA VALENCIA, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 11, Series of 2016 of the Municipality of Nueva Valencia authorizing its Annual Executive Budget, Fiscal Year 2017 involving an appropriation of One Hundred Seven Million Six Hundred Forty Thousand Five Hundred Ninety Two Pesos (₱107,640,592.00) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of Hon. David G. Gano, duly seconded by Hon. Dan Elby C. Habaña, Hon. Diosdado G. Gonzaga, Hon. Josefina G. de la Cruz, Hon. Rex G. Fernandez and Hon. Cyril C. Beltran;

THE 8TH SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 11, Series of 2016 authorizing the Annual Executive Budget, Fiscal Year 2017 of the Municipality of Nueva Valencia, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 11, Series of 2016 subject to the following conditions:

1. The LGU shall observe the PS cap limitations.
2. The LGU has to provide additional appropriation for Senior Citizens and Persons with Disability (PWD's) to conform with the provisions of the law.
3. Compliance with all existing laws, rules and regulations shall be the responsibility of the implementing LGU.


RESOLVED FURTHER, to require the Municipality of Nueva Valencia to comply with the herein conditions and notify this body of the action taken thereon;

RESOLVED STILL FURTHER, to inform the Municipality of Nueva Valencia that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law;



ADOPTED. March 7, 2017.


