RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 006, SERIES OF 2016, AUTHORIZING THE ANNUAL EXECUTIVE BUDGET, BUDGET YEAR 2017 OF THE MUNICIPALITY OF BUENAVISTA, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 006, Series of 2016 of the Municipality of Buenavista authorizing its Annual Executive Budget, Budget Year 2017 involving an appropriation of One Hundred Twenty Two Million Four Hundred Thirty Thousand Pesos (₱122,430,000.00) was submitted to this Body for review pursuant to the provisions of Republic Act (R. A.) No. 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance;

NOW THEREFORE, on motion of Hon. David G. Gano, duly seconded by Hon. Dan Elby C. Habaña, Hon. Rex G. Fernandez and Hon. Aurelio G. Tionado;

THE 8TH SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 006, Series of 2016 authorizing the Annual Executive Budget, Budget Year 2017 of the Municipality of Buenavista, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 006, Series of 2016 subject to the following conditions:

- 1. The LGU shall observe the PS cap limitations.
- 2. The appropriations for the discretionary fund shall be adjusted to conform with the provision of the law.
- Compliance with all existing laws, rules and regulations shall be the responsibility of the implementing LGU.











RESOLVED FURTHER, to require the Municipality of Buenavista to comply with the herein conditions and notify this body of the action taken thereon;

RESOLVED STILL FURTHER, to inform the Municipality of Buenavista that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law;

RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of Buenavista for information.
