MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is entered into by and between Dr. Catalino Gallego Nava Provincial Hospital, San Miguel, Jordan, Guimaras, represented by Hon. Samuel T. Gumarin, MD, MPH, Governor, Province of Guimaras, herein referred to as First party; and Erwin G. Young of legal age, Filipino with office address at Family Diagnostic Center, J and B3 Building, Quezon St., Iloilo City, Philippines, hereinafter referred to as the Second Party.

WITNESSETH

WHEREAS, the Second Party is the owner of Family Diagnostic Center which provides CT Scan available for patients of the First Party;

WHEREAS, the First Party does not offer services such as CT Scan;

WHEREAS, the Second Party accepts the proposal offered by the First Party that the Second Party shall provide the CT Scan to the patients of the First Party as maybe scheduled during its business hours, However, it shall be the patients decision where to go and the hospital cannot be faulted if patients referred goes to any another center;

NOW THEREFORE, for and in consideration of the foregoing premises setforth, the parties have hereby agreed to the following terms and conditions:

- 1. The First Party hereby agrees to allow the Second Party to provide services to the patients of the First Party;*
- 2. The agreement shall remain in force for a period effective January 26, 2018 until January 25, 2019 and shall be renewable at the option of either party;*
- 3. Anyone of the parties, who decides to pre-terminate this contract, shall give the other party sixty (60) days written notice prior to termination;*
- 4. Violation of any of the terms and conditions of the contract shall be grounds for termination of this contract.*

RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, DCGNPH, Family Diagnostic Center and all others concerned for information.
