**RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF GUIMARAS THE MEMORANDUM OF AGREEMENT WITH THE MUNICIPALITY OF NUEVA VALENCIA FOR THE PROVISION OF FINANCIAL ASSISTANCE IN RELATION TO PARAW REGATTA ACTIVITY**

WHEREAS, the Provincial Government of Guimaras will be hosting the 2018 Guimaras Paraw Regatta on February 9-10, 2018 as a preliminary activity of the 2018 Iloilo Paraw Regatta Celebration on February 9-17, 2018;

WHEREAS, the Municipality of Nueva Valencia will be spearheading the activities for the Bangkarera sa Paraw on February 9, 2018 at Puyo Wharf and Sinamba sa Paraw on February 17, 2018 in Iloilo City;

WHEREAS, the Honorable Governor in his letter dated January 30, 2018, requested for an authority to sign for and in behalf of the Provincial Government of Guimaras the Memorandum of Agreement with the Municipality of Nueva Valencia for the provision of financial assistance in the total amount of ₱350,000.00 (₱230,000.00 for Bangkarera sa Paraw and ₱120,000.00 for Sinamba sa Paraw) to the Municipal Government of Nueva Valencia;

WHEREAS, this Honorable Body finds the request to be in order, thereby interposing no objection on such request; the actual disbursement of funds however shall be subject to the usual accounting and auditing rules and regulations.

RESOLVED, to authorize Governor Samuel T. Gumarin, MD, MPH to sign for and in behalf of the Provincial Government of Guimaras the following:

### MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement entered by and between:

The Provincial Government of Guimaras represented by **HON. SAMUEL T. GUMARIN, MD. MPH.**, with office address at San Miguel, Jordan, Guimaras, Philippines referred hereinafter as the **FIRST PARTY**;

and

The Municipality of Nueva Valencia represented by **HON. EMMANUEL C. GALILA** with office address at Poblacion, Nueva Valencia, Guimaras referred hereinafter as the **SECOND PARTY**;

WITNESSETH:

WHEREAS, the Iloilo Paraw Regatta Foundation invited the Provincial Government of Guimaras (PGG) to participate in the 2018 Iloilo Paraw Regatta Celebration on February 9-17, 2018.

WHEREAS, the PGG agreed to host the 2018 Guimaras Paraw Regatta on February 9-10, 2018 for the preliminary activities of Paraw in partnership with Iloilo Paraw Regatta Foundation.

WHEREAS, the said event will focus on different water sports and Paraw related activities such as Bangkarera sa Paraw, Miniature Paraw Race, Jetski Amazing Race, Lighted Paraw, Pamunit sa Paraw, Miniature Paraw Making, Pinta Baroto, Furniture Making, Sinamba, and Ms. Paraw Regatta (Talent Competition).

WHEREAS, some of the Paraw Regatta activities will be spearheaded by the municipalities concerned that often organized the same event.

WHEREAS, Bangkarera sa Paraw and Sinamba sa Paraw will be spearheaded by the Municipality of Nueva Valencia that will take place on February 9, 2018 at Puyo, Nueva Valencia, Guimaras and on February 17, 2018 at the Iloilo City for Sinamba sa Paraw.

WHEREAS, The **FIRST PARTY** which is the Provincial Government of Guimaras (PGG):

- Provides financial assistance of Php350,000.00 (Php230,000.00 for Bangkarera sa Paraw and Php120,000.00 for Sinamba sa Paraw).
- Requires the submission of proposals based on the budget mentioned above.
- Coordinates with the **SECOND PARTY** on the updates from Iloilo Paraw Regatta Foundation.
- Requires the municipality to provide a copy of liquidation not later than one month after the conduct of the above-mentioned activities.



WHEREAS, The **SECOND PARTY** which is the Municipality of Nueva Valencia will:


- Submit proposals to the **FIRST PARTY** related to the conduct of Bangkarera sa Paraw and participation to Sinamba sa Paraw.
- Identifies participants to the conduct of Bangkarera and participation to Sinamba sa Paraw.
- Coordinates and conduct meetings with the participants on the mechanics of the above-mentioned activities.
- Attend meetings called by the **FIRST PARTY** and Iloilo Paraw Regatta Foundation.
- Oversees and monitors the management of funds and resources of the above-mentioned activities.
- Comply with the requirements of Section 3.1.3 of COA Circular 2012-001, particularly on the required liquidation of fund transfer to include submission of the following to the Provincial Government.
  - a. Report of Checks Issued and Report of Disbursements certified correct by the Municipal Accountant, approved by Municipal Mayor, and duly audited by the Auditor of the Municipal Government.
  - b. Copy of Credit Notice issued by the Auditor of the Municipal Government; and
  - c. Copy of OR issued for the refund of unexpended/unutilized balance of fund transfer.

This Memorandum of Agreement contains the complete understanding of the parties and may not be amended or modified except through another agreement in writing duly executed by all parties.


