RESOLUTION NO. 102

RESOLUTION DECLARING ORDINANCE NO. 06, SERIES OF 2017 OF THE MUNICIPALITY OF NUEVA VALENCIA ENTITLED: “AN ORDINANCE PROHIBITING OPEN DEFECATION BY ANY PERSON IN ANY PLACE OTHER THAN IN SANITARY TOILET OR COMFORT ROOM AND REQUIRING A SANITARY TOILET/COMFORT ROOM IN EVERY HOUSEHOLD WITHIN THE JURISDICTION OF THE MUNICIPALITY OF NUEVA VALENCIA, GUIMARAS, PROVIDING PENALTIES THERETO AND ALLOCATING FUNDS THEREFORE” AS VALID AND WITHIN THE POWERS OF THE SANGGUNIANG BAYAN TO ENACT, EXCEPT FOR CERTAIN PROVISIONS

WHEREAS, for review by this Honorable Body is Ordinance No. 06, Series of 2017 of the Municipality of Nueva Valencia entitled: *“An Ordinance Prohibiting Open Defecation by Any Person in Any Place Other Than in Sanitary Toilet or Comfort Room and Requiring a Sanitary Toilet/Comfort Room in Every Household Within the Jurisdiction of the Municipality of Nueva Valencia, Guimaras Providing Penalties Thereto and Allocating Funds Therefore”*;

WHEREAS, said Ordinance No. 6 was referred to the Committee on Rules that rendered a Committee Report which was adopted by this Honorable Body in its regular session of even date, recommending to declare said Ordinance as valid, except for the phrase as appearing in paragraphs a, b, c of Section 7-Penal Provisions, which is deemed beyond the powers of the Sangguniang Bayan, to wit:

“and to clean the area where the violation was made and to appear before the Municipal Health Officer (MHO) for health and sanitation orientation”

WHEREAS, the aforementioned provisions are declared ultra-vires and invalid;

NOW THEREFORE, on motion of Honorable Cyril C. Beltran, unanimously seconded;






