RESOLVED, to authorize Gov. Samuel T. Gumarin, M.D., M.P.H. to sign for and in behalf of the Provincial Government of Guimaras, the following:

### MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement entered by and between:

The Provincial Government of Guimaras represented by Hon. Samuel T. Gumarin, MD, MPH, with office address at San Miguel, Jordan, Guimaras, Philippines referred hereinafter as the FIRST PARTY;

-and-

PINTADOS DE PASSI OF PASSI CITY represented by MR. MARIO MOGOTE, Tribe Manager, with office address at Agdahon, Passi City referred hereinafter as the SECOND PARTY;

WITNESSETH:

WHEREAS, the Provincial Government of Guimaras (PGG) will be celebrating its 2018 Manggahan Festival and 25<sup>th</sup> Anniversary Celebration of Provincehood on May 11-22, 2018;

WHEREAS, to mark the Silver Anniversary of Manggahan Festival, festivals from different cities and provinces in the country are invited to showcase their rich culture and history in Guimaras through Cultural Presentation;

WHEREAS, the Invitational Cultural Presentation is scheduled on May 20, 2018, 2 to 4 pm as part of the said grand celebration;

WHEREAS, Pintados de Passi of Passi City was identified as one of the participants for the said event;

WHEREAS, the FIRST PARTY which is the Provincial Government of Guimaras (PGG):

- 1. Provides Financial Assistance of ₱80,000.00 and download the money to the Second Party.
- 2. Provides billeting schools for the participants.
- 3. Provides a team to assist the hubon on their needs in the duration of their stay in the island.
- 4. Assign police and rescue team at the billeting area and in the performance areas to ensure the security and safety of the delegates.
- 5. Provides two (2) jeepneys and one (1) truck for the hauling of props, drums and contingents on their arrival and departure from the island.
- 6. Coordinates with pump boats and Roro for the convenient transport of the delegates.
- 7. Requires the submission of the copy of liquidation report by the SECOND PARTY one month after the activity.


WHEREAS, the SECOND PARTY which is the Pintados de Passi:

- Performs in the three (3) designated areas on May 20, 2018, 2 to 4 pm during the 2018 Manggahan Festival (Invitational Cultural Presentation).
- Shoulders the accommodation of the support staff assisting the tribe and the expenses to be incurred like the food of the delegation, transportation outside the Province of Guimaras, and the other needs of the Hubon.
- Coordinates with the team provided by the FIRST PARTY on any matters arising while in the Province of Guimaras.
- Coordinates with the sound system provided at the designated performance area on the technical requirements (number of microphones, mixer adjustments and others as needed).
- Submit the copy of liquidation report to the FIRST PARTY one month after the conduct of the activity as per COA Guideline to comply with the requirements of Section 3.1.3 of COA Circular 2012-001, particularly on the required liquidation of fund transfer to include submission of the following to the provincial government:
  - a. Report of checks issued and Report of Disbursements certified correct by the Municipal Accountant, approved by Municipal Mayor and duly audited by the Auditor of the Municipal Government.
  - b. Copy of Credit Notice Issued by the Auditor of the Municipal Government and
  - c. Copy of OR issued for the refund of unexpected/unutilized balance of fund transfer.


