RESOLUTION APPROVING THE ADDITIONAL AMOUNT OF ₱6,692.60 FOR THE 20% DEVELOPMENT FUND, CY 2018 TO BE ALLOCATED AS ADDITIONAL FUNDS FOR THE WATER CONSERVATION PROJECT (CONSTRUCTION OF UNDERGROUND RAIN WATER COLLECTION FACILITY) AS PER PDC RESOLUTION NO. 2, SERIES OF 2018

WHEREAS, based on the adjusted IRA share of the province for CY 2018, there is a difference of ₱6,692.60 for the 2018 20% Development Fund, however, said amount is not sufficient to fund another priority project;

WHEREAS, included in the list of programs and projects approved for funding in the 2018 20% DF is the Water Conservation Project (Construction of Underground Rain Water Collection Facility) with a total project cost of ₱9M, however, only ₱4,749,666.40 was allocated;

WHEREAS, the Honorable Governor, has endorsed to this Body, PDC Resolution No. 2, Series of 2018 entitled: *“Approving and Endorsing for approval of the Sangguniang Panlalawigan the additional amount of ₱6,692.60 for the 20% Development Fund CY 2018 to be allocated as additional funds for the Water Conservation Project (Construction of underground rain water collection facility)”*;

NOW, THEREFORE, on motion of Honorable David G. Gano, unanimously seconded;

THE 8th SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to approve the additional amount of ₱6,692.60 for the 20% Development Fund, CY 2018 to be allocated as additional funds for the Water Conservation Project (Construction of Underground Rain Water Collection Facility) as per PDC Resolution No. 2, Series of 2018.






