RESOLUTION EXPRESSING THE SENSE OF THE SANGGUNIANG PANLALAWIGAN ITS NON-OBJECTION FOR FARE INCREASE FROM ₱14.00 TO ₱15.00 OR A MAXIMUM INCREASE OF ₱1.00 FOR DAYTIME NAVIGATION AND FROM ₱20.00 TO ₱22.00 OR A MAXIMUM INCREASE OF ₱2.00 FOR NIGHT TIME NAVIGATION FOR JORDAN-ILOILO AND VICE VERSA ROUTE OF THE JORDAN MOTOR BANCA COOPERATIVE, OR IN THE AMOUNT FOUND REASONABLE BY THE MARITIME INDUSTRY AUTHORITY WHICH IN NO CASE SHALL GO BEYOND THE MAXIMUM AMOUNT STATED

WHEREAS, before this Honorable Body is the request from MARINA for comment anent the intent of Jordan Motor Banca Cooperative for fare increase from ₱14.00 to ₱16.00 for daytime navigation and from ₱20.00 to ₱25.00 navigation for Jordan-Iloilo and vice versa route;

WHEREAS, the matter was referred to the Committee on Transportation that rendered a Committee Report and was adopted by this Honorable Body in its regular session of even date, recommending for a fare increase from ₱14.00 to ₱15.00 for an increase of ₱1.00 (maximum) for daytime navigation and from ₱20.00 to ₱22.00 or an increase of ₱2.00 (maximum) for night time navigation, or in the amount found reasonable by the Maritime Industry Authority, which in no case shall go beyond the maximum amount stated;

NOW, THEREFORE, on motion of Honorable Cresente P. Chavez, Jr., unanimously seconded;






