AN ORDINANCE AMENDING APPROPRIATION ORDINANCE NO. 29, SERIES OF 2017 ENTITLED: "AN ORDINANCE AUTHORIZING THE 2018 ANNUAL EXECUTIVE BUDGET FOR THE GENERAL FUND OF THE PROVINCE OF GUIMARAS IN THE TOTAL AMOUNT OF ₱583,143,967.00 COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE PROVINCIAL GOVERNMENT FOR FISCAL YEAR 2018 AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE"

WHEREAS, this Honorable Body in its regular session held on December 13, 2017, passed Appropriation Ordinance No. 29, Series of 2017 authorizing the 2018 Annual Executive Budget for the General Fund of the Province of Guimaras in the amount of ₱583,143,967.00 covering the various expenditures for the operation of the provincial government for Fiscal year 2018;

WHEREAS, the Honorable Governor in his Budget Message has specified the creation and/or funding of certain positions which are considered vital to the operation of the requesting offices, however, due to inadvertence, the same was not included in one of the provisions of Appropriation Ordinance No. 29;

WHEREAS, it is really the intent of the 8th Sangguniang Panlalawigan to create the said positions pursuant to the Budget Message of the Honorable Governor;

Section 1.
