AN ORDINANCE AMENDING "APPROPRIATION ORDINANCE NO. 34, SERIES OF 2016, ENTITLED: 'AN ORDINANCE AUTHORIZING THE 2017 ANNUAL EXECUTIVE BUDGET FOR THE GENERAL FUND OF THE PROVINCE OF GUIMARAS IN THE TOTAL AMOUNT OF FIVE HUNDRED THIRTY NINE MILLION, SIX HUNDRED EIGHTY THREE THOUSAND NINE HUNDRED NINETY SIX PESOS (₱539,683,996.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE PROVINCIAL GOVERNMENT FOR FISCAL YEAR 2017 AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE' BY CHANGING THE PROJECT TITLE "CONSTRUCTION OF 2-STOREY BUILDING (PROVINCIAL TOURISM OFFICE PHASE II)" TO "CONSTRUCTION OF 2-STOREY BUILDING (PROVINCIAL TOURISM OFFICE PHASE I) UNDER THE TOURISM OFFICE' CAPITAL OUTLAY

Section 1. Appropriation Ordinance No. 34, Series of 2016 entitled: "An Ordinance authorizing the 2017 Annual Executive Budget for the general fund of the Province of Guimaras in the total amount of Five Hundred Thirty Nine Million Six Hundred Eighty Three Thousand Nine Hundred Ninety Six Pesos (P539,683,996.00) covering the various expenditures for the operation of the provincial government for Fiscal Year 2017 and appropriating the necessary funds for the purpose" is hereby amended by changing the project title: " Construction of 2-Storey Building (Provincial Tourism Office Phase II)" to "Construction of 2-Storey Building (Provincial Tourism Office Phase I) under the Tourism Office' Capital Outlay.


Section 2. Separability Clause- If any part or provision of this Ordinance shall be declared unconstitutional or unlawful by the court, or suspended or revoked by competent authorities, all other provisions not otherwise affected thereby shall remain valid and effective.


Section 3. Repealing Clause- Any Ordinance contrary or inconsistent with any provisions of this Ordinance is hereby repealed, amended or modified accordingly.


Section 4. Effectivity. This Ordinance shall take effect upon approval.


