RESOLUTION REQUESTING HIS EXCELLENCY PRESIDENT RODRIGO ROA DUTERTE FOR THE PROVISION OF WATER AMBULANCE FOR THE PROVINCE OF GUIMARAS

WHEREAS, Guimaras is a small island province in Western Visayas, created in May 1992 and is situated between the big islands of Panay and Negros;

WHEREAS, the province's leadership many years back has initiated the construction of basic infrastructure facilities among which is the Doctor Catalino Gallego Nava Provincial Hospital (DCGNPH) operating as an economic enterprise not for profit but for its sustainability;

WHEREAS, the DCGNPH is operating as a Level 1 category hospital and due to lack of hospital equipment and medical specialists, patients who need intensive care are being referred to tertiary level hospitals operating in the City of Iloilo;

WHEREAS, in cases where patients have to be transported to hospitals in Iloilo City, these patients have to endure aboard a passenger motorbanca which is not equipped with life saving devices that put in peril the lives of these patients;

WHEREAS, it is the earnest hope of the provincial leadership and its constituency to be a beneficiary of a water ambulance which is designed to withstand strong wind and heavy rain and equipped with the necessary medical equipment;

WHEREAS, the provision of a water ambulance to transport patients from Guimaras to Iloilo City provides more chances for patients' survival as they will be transported safely and with ease, comfort and without delay even during inclement weather;


THE 9TH SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED FURTHER, to send a copy of this resolution to His Excellency President Rodrigo Roa Duterte for information and favorable action.


