VI IN RELATION TO THE TRANSFER OF FUNDS IN THE AMOUNT OF ₱500,000.00 FOR THE CONSTRUCTION OF CSC BUILDING, PHASE II

WHEREAS, the Honorable Governor in his letter dated February 11, 2020 requested for an authority to sign for and in behalf of the Provincial Government, the Memorandum of Agreement with the Civil Service Commission (CSC) for the transfer of funds in the amount of PHP 500,000.00 for the construction of CSC Building, Phase II;

WHEREAS, this Honorable Body interposes no objection to the said request on the terms, conditions and stipulations set forth in the draft Memorandum of Agreement presented before it;

MEMORANDUM OF AGREEMENT

This Agreement made and entered into this _____ by and between:

The CIVIL SERVICE COMMISSION REGIONAL OFFICE NO. VI (CSC RO VI), a Constitutional body organized and existing under and by virtue of the laws of the Republic of the Philippines with principal address at No. 7 Oñate Street, Manudriao, Iloilo City, represented in this Act by its Regional Director, **NELSON G. SARMIENTO**.

-and-

The PROVINCIAL GOVERNMENT OF GUIMARAS, a local government unit duly created under the laws of the Philippines, with office address at San Miguel, Jordan, Guimaras represented herein by its Provincial Governor, **HON. SAMUEL T. GUMARIN**.

-witness that-

WHEREAS, the Civil Service Commission (CSC) has established a Field Office (FO) in San Miguel, Jordan, Guimaras, supported by the PROVINCIAL GOVERNMENT OF GUIMARAS, from social preparation up to its implementation;

WHEREAS, CSC RO VI and the PROVINCIAL GOVERNMENT OF GUIMARAS recognize that a CSC FO in Guimaras is a vital and indispensable component of community development and is beneficial to the national, provincial, and municipal officials and employees;

WHEREAS, the PROVINCIAL GOVERNMENT OF GUIMARAS has finished implementing the construction of the CSC FO-Guimaras in Jordan, Guimaras as part of its commitment to support the Civil Service Commission. The construction was covered by a Memorandum of Agreement dated April 5, 2018 between the CSC Chairperson Alicia dela Rosa-Bala and Hon. Samuel T. Gumarin;

WHEREAS, the PROVINCIAL GOVERNMENT OF GUIMARAS has turned over the CSC FO-Guimaras building and submitted documentary reports for liquidation of the construction to CSC RO VI.

WHEREAS, the PROVINCIAL GOVERNMENT OF GUIMARAS wants to implement the construction of Construction of the CSC FO – Guimaras Building Phase II in addition to the completed CSC FO-Guimaras building, said activity is hereinafter referred to as the PROJECT;

WHEREAS, the CSC RO VI has an allocated budget of Five Hundred Thousand Pesos (P500,000.00) for the PROJECT. Said amount is provided in the Fiscal Autonomy Trust Receipt Contingency Reserved Fund (FATR CRF) as approved by CSC Chairperson Alicia dela Rosa-Bala in her letter dated September 6, 2019;

NOW THEREFORE, the parties hereby agree that;

1. OBLIGATIONS OF THE CIVIL SERVICE COMMISSION REGIONAL OFFICE NO. VI

- 1.1 Transfer to the PROVINCIAL GOVERNMENT OF GUIMARAS the PROJECT cost estimated at no more than Five Hundred Thousand Pesos (P500,000.00) in accordance with the schedule of Fund Transfer/Releases subject to pertinent government rules and regulations;
- 1.2 Provide such other necessary requirements to concretize the PROJECT, as may be specified by the PROVINCIAL GOVERNMENT OF GUIMARAS;
- 1.3 Designate a representative and/or PROJECT team to coordinate with the PROVINCIAL GOVERNMENT OF GUIMARAS on all matters relative to the implementation or completion of the PROJECT.

3.0 RESPONSIBILITIES OF BOTH PARTIES

- 3.1 Jointly monitor, through their respective PROJECT Management and Monitoring Counterpart Teams, the implementation and progress of the PROJECT, ensure the acceptability and adherence to design and construction standards of the completed works prior to the issuance of the final Certificate of Acceptance.
- 3.2 The parties agree to sign, execute, and deliver the Schedule of Transfer/Release of PROJECT Funds, construction schedule, and such other agreements and documents in furtherance, or in the implementation of this Agreement, all of which subsequent documents shall form integral parts hereof.

4.0 SEPERABILITY CLAUSE

Any provision of this Agreement declared illegal, invalid or unconstitutional by any competent authority shall not affect the rest of the provisions which shall remain valid, subsisting, and binding.

5.0 EFFECTIVITY

This agreement shall take effect upon the signing of the parties thereto,


RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, Civil Service Commission and all other concerned offices for information and appropriate action.
