RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 07, SERIES OF 2019 OF THE MUNICIPALITY OF NUEVA VALENCIA ENTITLED: "AN ORDINANCE REGULATING THE MANUFACTURE, SALE, DISTRIBUTION, POSSESSION OR USE OF FIRECRACKERS OR PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR EXPLOSIVE DEVICES IN THE MUNICIPALITY OF NUEVA VALENCIA, GUIMARAS, AND PROHIBITING THE EXPLODING OF FIRECRACKERS OR OTHER SIMILAR EXPLOSIVES EXCEPT DURING COMMUNITY FIREWORKS DISPLAY" AS OPERATIVE, VALID AND WITHIN THE POWERS OF THAT MUNICIPALITY TO LEGISLATE
