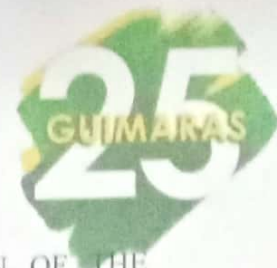

GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE MUNICIPAL GOVERNMENT OF NUEVA VALENCIA FOR THE RELEASE OF FINANCIAL ASSISTANCE TO THE 6<sup>TH</sup> BANGKARERA SA NUEVA VALENCIA IN CELEBRATION OF THE 79<sup>TH</sup> FOUNDATION DAY AND 12<sup>TH</sup> SADSARAN FESTIVAL**

WHEREAS, the Honorable Governor in his letter dated January 20, 2020 is requesting for an authority to sign or and in behalf of the provincial government the Memorandum of Agreement with the Municipal Government of Nueva Valencia as represented by Mayor Emmanuel C. Galila in connection with the financial assistance for the 6<sup>th</sup> Bangkarera sa Nueva Valencia in the celebration of the 79<sup>th</sup> Foundation Day and 12<sup>th</sup> Sadsaran Festival;

RESOLVED, to authorize Governor Samuel T. Gumarin, MD, MPH to sign for and in behalf of the provincial government the following Memorandum of Agreement to wit:

### MEMORANDUM OF AGREEMENT

#### KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is entered into this \_\_\_\_\_ at the Provincial Capitol, Province of Guimaras by and between:

The Provincial Government of Guimaras, a local government unit established under existing laws of the Republic of the Philippines, with principal address at the Provincial Capitol, Brgy. San Miguel, Jordan, Guimaras, represented herein by the Provincial Governor, the **HONORABLE SAMUEL T. GUMARIN, MD, MPH** hereinafter referred to as the First Party;

-and-

The Municipal Government of Nueva Valencia, a local government unit established under existing laws of the Republic of the Philippines, with principal address at Poblacion, Nueva Valencia, Guimaras, represented herein by the Municipal Mayor, the **HONORABLE EMMANUEL C. GALILA**, hereinafter referred to as the Second Party;

#### WITNESSETH

**WHEREAS**, under paragraph Section 16 of the Local Government Code (RA 7160), provides that: "Every local government unit shall exercise the powers expressly granted, those necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

**WHEREAS**, in order to realize the vision of the Provincial Government of Guimaras to be the agri-eco-tourism capital of the region, it supports other Local Government Units initiated programs, projects and activities related to the preservation and enrichment of culture and enhancement of economic prosperity;

**WHEREAS**, the Municipal Government of Nueva Valencia promotes the development and enhancement of local culture and arts through the conduct of 6<sup>th</sup> Bangkarera sa Nueva Valencia in celebration of the 79<sup>th</sup> Foundation Day and 12<sup>th</sup> Sadsaran Festival which also open opportunities for economic empowerment thereby contributing to the poverty reduction goal of the municipality;

**WHEREAS**, the Province, under the dynamic leadership of its Governor, The Hon. Samuel T. Gumarin, M.D., M.P.H., is committed to promote tourism related activities to enhance economic prosperity by providing financial assistance to the Second Party for their 6<sup>th</sup> Bangkarera sa Nueva Valencia in celebration of the 79<sup>th</sup> Foundation Day and 12<sup>th</sup> Sadsaran Festival;

**NOW THEREFORE**, for and in consideration of the foregoing premises, the parties hereto have agreed to enter into this Memorandum of Agreement under the following terms and conditions:

**1.0 The PROVINCE shall:**

- 1.1 Provide financial assistance in the amount of **Two Hundred Thousand Pesos (P200,000.00)** to the SECOND PARTY for their 6<sup>th</sup> Bangkarera sa Nueva Valencia in celebration of the 79<sup>th</sup> Foundation Day and 12<sup>th</sup> Sadsaran Festival;

**2.0 The MUNICIPAL GOVERNMENT OF NUEVA VALENCIA shall:**

- 2.1 Undertake the immediate implementation of their 6<sup>th</sup> Bangkarera sa Nueva Valencia in celebration of the 79<sup>th</sup> Foundation Day and 12<sup>th</sup> Sadsaran Festival upon release of financial assistance by the FIRST PARTY; and
- 2.2 Abide with auditing rules and regulations relevant to this matter.

**3.0 Modification/Amendment and Effectivity**

- 3.1 Any amendment or modification in this agreement shall be translated in writing signed by both parties and shall form part of this agreement; and
- 3.2 The term of this agreement shall take effect immediately upon the date of signing of the **Memorandum of Agreement**.


RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, Municipal Mayor of Nueva Valencia and all other concerned offices for information and appropriate action.
