RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 02, AUTHORIZING SUPPLEMENTAL BUDGET NO. 02, SERIES OF 2020 FOR THE GENERAL FUND OF THE MUNICIPALITY OF NUEVA VALENCIA, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS


NOW THEREFORE, on motion of Honorable David G. Gano, Chairperson, Committee on Appropriations and duly seconded by all members;


THE 9th SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 02, authorizing Supplemental Budget No. 02, Series of 2020 for the General Fund of the Municipality of Nueva Valencia, Province of Guimaras operative in its entirety, effective as of the date fixed in Appropriation Ordinance No. 02, subject to the posting requirements under Section 59 of R.A. 7160 and subject further to the observance of the following:









- 1. Guidelines and procedures in the collection and utilization of the pooled Resources to Fund Social Amelioration Measures under R.A. No. 11469 "Bayanihan to Heal as One Act" per Joint Circular No. 1 dated March 30, 2020.
- 2. Guidelines on the release and utilization of the Bayanihan Grant to Cities and Municipalities per LBC No. 125 dated April 7, 2020.

RESOLVED FURTHER, to inform the Municipality of Nueva Valencia that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law.

RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of Nueva Valencia, for information.
