**RESOLUTION RETURNING WITHOUT ACTION “APPROPRIATION ORDINANCE NO. 002, SERIES OF 2020 OF THE MUNICIPALITY OF BUENAVISTA EMBODYING SUPPLEMENTAL BUDGET FISCAL YEAR 2020 FOR THE GENERAL FUND TO BE SOURCED OUT FROM THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) TO FUND CORONA VIRUS DISEASE (COVID)-19 RELATED ACTIVITIES” WITH THE INSTRUCTION TO COMPLY WITH THE RECOMMENDATIONS SET FORTH**

WHEREAS, Appropriation Ordinance No. 002, Series of 2020 of the Municipality of Buenavista authorizing its Supplemental Budget Fiscal year 2020 was submitted to this Body for review pursuant to the provisions of Republic Act 7160;

WHEREAS, said Appropriation Ordinance No. 2019-12 was referred to the Provincial Budget Office for its comment and recommendation;

WHEREAS, the Provincial Budget Office in its 3<sup>rd</sup> Endorsement dated May 13, 2020, is returning Appropriation Ordinance No. 002 to this Honorable Body with the findings that in order to ensure compliance to the Local Budget Operations Manual for LGUs, 2016 Edition, the LGU shall reflect the Unappropriated Balance per last Supplemental Budget No. 1, dated March 12, 2020 in the amount of ₱602,457.24 for the General Fund and ₱14,963.15 for Local Economic Enterprise and to revise its LBP Form No. 9 to comply with the review findings and enact a new ordinance authorizing the Supplemental Appropriation for review by this Honorable Body;

WHEREAS, giving merit to the recommendation of the Provincial Budget Office, this Honorable Body deems it proper to return to the Municipality of Buenavista, its Appropriation Ordinance No. 002, Series of 2020, embodying Supplemental Budget Fiscal Year 2020 for the General Fund to be sourced out from the Bayanihan Grant to Cities and Municipalities (BGCM) to fund corona virus disease (COVID)-19 related activities”, but without prejudice to its re-submission provided that compliance to the recommendations of the Provincial Budget Office be effected;




