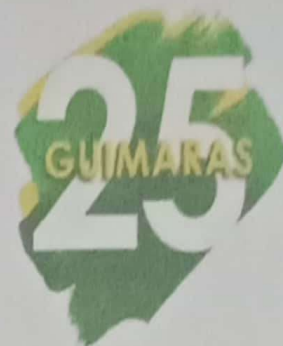

RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOOD AUTHORITY FOR THE PURCHASE OF 2,500 SACKS OF RICE

WHEREAS, the Honorable Governor in his letter dated May 15, 2020 is requesting for an authority to sign for and in behalf of the provincial government the Memorandum of Agreement with the National Food Authority as represented by its Provincial Manager Jose Mario Adan D. Pacificador for the purchase of another Two Thousand Five Hundred (2,500) sacks of rice for the relief operation in connection with the COVID 19 pandemic;

WHEREAS, this Honorable Body finds the request to be in order, thereby authorizing the Honorable Governor to purchase additional Three Thousand sacks of rice and to sign the Memorandum of Agreement on the terms, conditions and stipulations of the draft Agreement presented before it and disbursement of funds shall be subject to the usual accounting and auditing rules and procedures;

NOW THEREFORE, on motion of Honorable Josefina G. de la Cruz, Chairperson Committee on Social Services and duly seconded by all members;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This MEMORANDUM OF AGREEMENT made and executed by and between:

*The Provincial Government of Guimaras represented herein by the **Governor, HONORABLE SAMUEL T. GUMARIN, M.D., M.P.H.**, referred as the **PROVINCE OF GUIMARAS**;*

-AND-

***NATIONAL FOOD AUTHORITY**, a government agency mandated to deliver and supply rice, with address at Quintin Salas, Jaro, Iloilo City, Philippines, represented by **PROVINCIAL MANAGER JOSE MARIO ADAN D. PACIFICADOR** herein referred as **NATIONAL FOOD AUTHORITY**;*

WITNESSETH

***WHEREAS**, President Rodrigo Roa Duterte issued Proclamation No. 922 declaring a State of Public Health Emergency Throughout the Philippines on March 8, 2020;*

***WHEREAS**, the President Rodrigo Roa Duterte likewise issued Proclamation No. 929 declaring a state of calamity throughout the Philippines due to Corona Virus Disease 2019;*

***WHEREAS**, the **PROVINCE OF GUIMARAS** as part of its preparation in fighting COVID-19 needs to purchase additional Two Thousand Five Hundred (2,500) bags/sacks of rice (50 kilos each bag/sack) from the National Food Authority to provide for the needs of its constituents.*

***WHEREAS**, the **PROVINCE OF GUIMARAS**, through its Bids and Awards Committee recommended to **GOVERNOR, HONORABLE SAMUEL T. GUMARIN, M.D., M.P.H.** Head of the Procuring Entity to award the contract to **NATIONAL FOOD AUTHORITY** as the servicing agency through the Agency to Agency mode of procurement as provided in Sec. 53.5 of Revised Implementing Rules and Regulations of Republic Act No. 9184 otherwise known as the Government Procurement Reform Act per BAC Resolution No. 234-2020 dated May 14, 2020;*

***WHEREAS**, in Agency to Agency mode of procurement, a memorandum of agreement is a requirement to be executed by the **Head of Procuring Entity ("HOPE" for brevity)** and the **Servicing Agency** as prescribed in Annex "H" of the 2016 Revised Implementing Rules and Regulations entitled "Consolidated Guidelines for the Alternative Methods of Procurement, Letter V, Number 5, Letter (c), to wit:*

"X x x x x

*iv. In case of approval, the **HOPE** shall enter into a Memorandum of Agreement (MOA) with the Servicing Agency."*

***NOW THEREFORE**, in view of the foregoing premises, the parties herein agree on the following:*

A. THE NATIONAL FOOD AUTHORITY:

1. To supply and deliver to the Province of Guimaras Two Thousand Five Hundred (2,500) bags/sacks of rice (50 kilos per bag/sack) at P1,250 each amounting to a total of THREE MILLION ONE HUNDRED TWENTY FIVE THOUSAND PESOS ONLY (P3,125,000.00);
2. To deliver the Two Thousand Five Hundred (2,500) bags/sacks of rice upon due execution of this agreement after a resolution is passed by the Sangguniang Panlalawigan of the Province of Guimaras granting authority to its Governor to sign in the Memorandum of Agreement;

B. THE PROVINCE OF GUIMARAS:

To pay the amount of **THREE MILLION ONE HUNDRED TWENTY-FIVE THOUSAND PESOS Only (P3,125,000.00)** upon delivery of the above stated bags/sacks of rice to the Province of Guimaras.

IN WITNESS WHEREOF, the parties of this Agreement have on this _____ day of _____, 2020 hereunto set their hands at the bottom of this Agreement on Iloilo City, Philippines.






