RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH PAROLE AND PROBATION ADMINISTRATION, REGIONAL OFFICE VI FOR THE USE OF THE HALFWAY HOUSE AND LIVELIHOOD TRAINING CENTER LOCATED AT BARANGAY LANIPE, NUEVA VALENCIA AS QUARANTINE FACILITY

WHEREAS, the Honorable Governor in his letter dated May 18, 2020 is requesting for an authority to sign for and in behalf of the provincial government the Memorandum of Agreement with Parole and Probation Administration, Regional Office VI as represented by Regional Director Ms. Charito A. Zamora for the use of the Halfway House and Livelihood Training Center located at Barangay Lanipe, Nueva Valencia as quarantine facility for the returning Overseas Filipino Workers (OFWs), repatriated and stranded residents outside Region VI due to the COVID-19 pandemic;

WHEREAS, pursuant to Executive Order No. 45, Series of 2020 of the Honorable Governor, the province will now be accepting OFWs, repatriated and stranded residents outside of Region VI but will subject them to a mandatory quarantine;

WHEREAS, the Parole and Probation Office, Regional Office VI has offered to the provincial government the use of its Halfway House and Livelihood Training Center situated at Barangay Lanipe, Nueva Valencia as quarantine facility;

WHEREAS, this Honorable Body interposes no objection to the request on the terms, conditions and stipulations set forth in the draft Memorandum of Agreement presented before it;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This MEMORANDUM OF AGREEMENT made and executed by and between:

The Provincial Government of Guimaras represented herein by the Governor, HONORABLE SAMUEL T. GUMARIN, M.D., M.P.H., with office address at San Miguel, Jordan, Guimaras referred to as the PROVINCE OF GUIMARAS;

-AND-

The Parole and Probation Administration, Regional Office VI, a government agency situated at 4th Floor, Room 404, Hall of Justice, Iloilo City, Philippines, represented by its Regional Director, Ms. Charito A. Zamora, of legal age, Filipino referred to as PAROLE OFFICE;

WITNESSETH

WHEREAS, President Rodrigo Roa Duterte issued Proclamation No. 922 declaring a State of Public Health Emergency Throughout the Philippines on March 8, 2020;

WHEREAS, the President Rodrigo Roa Duterte likewise issued Proclamation No. 929 declaring a state of calamity throughout the Philippines due to Corona Virus Disease 2019;

WHEREAS, in Executive Order No. 45, Series of 2020 issued by Governor Samuel T. Gumarin, the Province will accept and will have to place the returning Overseas Filipino Workers (OFWs), Repatriated Residents and stranded residents outside Region VI for a mandatory quarantine;

WHEREAS, there must be a location/facility where the above-said persons should be housed and quarantined;

WHEREAS, the Parole Office has offered its building, "Halfway House" and Livelihood Training Center situated at Brgy. Lanipe, Nueva Valencia, Guimaras as quarantine facility for the said persons with an undertaking from the Province of Guimaras to shoulder the expenses related to the said quarantine facility, electricity, water and other incidental expenses related thereto;

NOW THEREFORE, in view of the foregoing premises, the parties herein agree on the following:

A. PAROLE OFFICE:

- 1. Authorize the Province of Guimaras to use the Halfway House and Livelihood Training Center as quarantine facility for returning Overseas Filipino Workers (OFWs), Repatriated Residents and stranded residents outside Region VI for free.

B. THE PROVINCE OF GUIMARAS:

- 1. To shoulder the expenses relative to the use of the said quarantine facility such as electricity, water and other incidental expenses related thereto.






