Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 7. Bids must be duly received by the BAC Secretariat at the address below on or before <u>June 25, 2020</u>, 9:00AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on <u>June25</u>, <u>2020</u>, <u>9:30AM</u> at <u>Provincial Capitol</u>, <u>San Miguel</u>, <u>Jordan</u>, <u>Guimaras</u>. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. In case of a tie among two or more bidders with the lowest responsive bid, the winning bidder shall be chosen through draw lots. The lucky bidder who would pick the paper with a "Congratulations" remark shall be declared as the final bidder having the LCRB and recommended for award of the contract.

The <u>Provincial Government of Guimaras</u> reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
