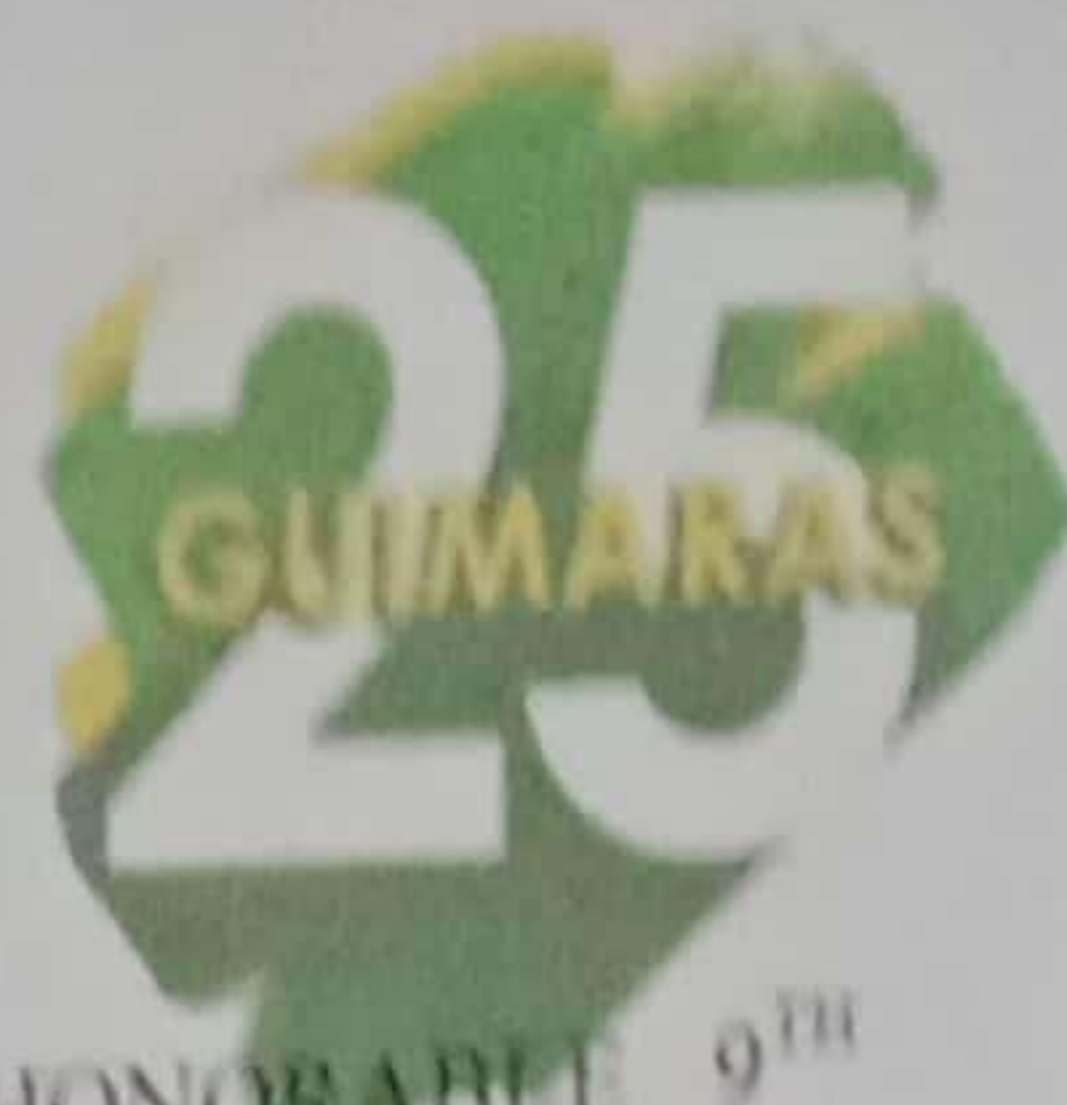

NOW THEREFORE, on motion of Honorable Cyril C. Beltran and duly seconded by all members;






