RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT THE DEED OF DONATION WITH THE DEPARTMENT OF HEALTH FOR THE DONATION OF TWO (2) UNITS AMBULANCE TO DCGNPH

WHEREAS, the Honorable Governor in his letter dated March 9, 2020 is requesting for an authority to sign for and in behalf of the provincial government the Deed of Donation with the Department of Health (DOH) as represented by Marlyn W. Convocar, MD, MPH, CESO III, Regional Director for the donation of two (2) units Ambulance to Dr. Catalino Gallego Nava Provincial Hospital;

WHEREAS, this Honorable Body, finding the request to be in order and beneficial to the provincial government, interposes no objection to grant the Honorable Governor the authority subject to the terms, conditions and stipulations set forth in the draft Deed of Donation presented before it;

NOW THEREFORE, on motion of Honorable Josefina G. de la Cruz, and duly seconded by all members;

### **DEED OF DONATION**

## KNOWN ALL MEN BY THESE PRESENTS:

This Deed of Donation made and executed by and between:

The **DEPARTMENT OF HEALTH**, a National Government Entity duly organized and existing under the laws of the Republic of the Philippines, hereinafter referred to as "DOH WV-CHD", with office address at Q. Abeto St., Mandurriao, Iloilo City, Philippines, herein represented by MARLYN W. CONVOCAR, MD, MPH, CESO III, Regional Director IV-Regional Office VI, as the **DONOR**;

The DR. CATALINO GALLEGO NAVA PROVINCIAL HOSPITAL, a local government unit duly organized and existing under the laws of the Republic of the Philippines, hereinafter referred to as LGU Hospital with office address at Jordan, Guimaras, herein represented by SAMUEL T. GUMARIN, Provincial Governor, as the DONEE.

In this Agreement, DOH and the Province of Guimaras are individually referred to as "Party" and collectively as "Parties".

#### WITNESSETH

WHEREAS, the State recognizes its mandate to provide equitable and accessible quality healthcare for all Filipinos;

WHEREAS, "Boosting Universal Health Care via FOURmula One for Health Plus (or F1+)" envisions quality health care to be more accessible to the poor and vulnerable population by ensuring the availability of functional health care facilities;

WHEREAS, the Health Facilities Enhancement Program (HFEP) aims to improve the delivery of health services through the upgrading of health facilities and provision of medical equipment in order to make them more responsive to the health needs of the population;

WHEREAS, the provision of ambulance shall contribute to the functionality of the health system and the delivery of quality health care;

WHEREAS, local government units are partners of the DOH in implementing health programs and in delivering quality health services;

NOW, THEREFORE, in consideration of the foregoing premises and subject to the conditions stipulated hereunder, the Department of Health hereby donates to the Dr. Catalino Gallego Nava Provincial Hospital, Jordan, Guimaras, two (2) units Ambulance including the equipment therein amounting to Four Million Nine Hundred Thousand Pesos (\$\mathbb{P}4,900,000.00\$), with the following specifications:

The Donee accepts the donation and undertakes to:

- Ensure that the ambulance is properly classified and recorded in the books of assets of the LGU
  or health facility;
- Ensure that within six (6) months upon receipt of the ambulance, said ambulance is licensed in
  its name and at its own expense, in accordance with the DOH Administrative Order regarding
  the Rules and Regulations Governing the Licensure of Land Ambulances and Ambulance
  Service Providers;
- Ensure the availability of health personnel, supplies, and other operational expenses necessary
  for the operation and maintenance of the ambulance and the equipment therein;
- Ensure that the ambulance is utilized in accordance with the definition and standards provided in the abovementioned DOH Administrative Order;
- 5. Ensure the rational use of the ambulance within the municipality or locality to maximize its benefit to the residents needing ambulance service;

6. Apply for the renewal of the ambulance vehicle registration with the Land Transportation Office (LTO) after three years (3) using its own resources. The Donce may transfer the vehicle registration under its name,

7. Designate the MHOCHOPHOLGU as the focal person who will be coordinating with the

DOH Regional Office for purposes of program monitoring and evaluation;

The Donor reserves the right to revoke this Deed of Donation in case any of the aforesaid conditions are not faithfully complied with by the Donce. In case this Deed of Donation is revoked, the Donce shall surrender the possession of the ambulance, including all its accessories and the equipment, to the Donor within fifteen (15) working days from receipt of the Notice of Revocation. Ownership of the said ambulance and equipment shall then vest to the Donor effective upon receipt by the Donee of the Notice of Revocation.

RESOLVED FURTHER, to inform the Municipality of Nueva Valencia that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law.

RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of Nueva Valencia, for information.
