RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH NATIONAL PRINTING OFFICE FOR THE SUPPLY OF ACCOUNTABLE FORMS OF THE PROVINCIAL TREASURY OFFICE UNDER THE AGENCY TO AGENCY PROCUREMENT AS PER R.A. 9184

WHEREAS, the Honorable Governor in his letter dated March 19, 2020 is requesting authority to sign for and in behalf of the Provincial Government the Memorandum of Agreement with the National Printing Office for the supply of Accountable Forms of the Provincial Treasury Office under the Agency to Agency Procurement as per R.A. 9184;

WHEREAS, this Honorable Body finds the request to be in order, thus interposing no objection on the same subject to the terms, conditions and stipulations set forth in the draft Memorandum of Agreement and disbursements of funds shall be subject to the usual accounting and auditing regulations;

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This MEMORANDUM OF AGREEMENT made and executed by and between:

The Provincial Government of Guimaras represented herein by the Governor, HONORABLE SAMUEL T. GUMARIN, M.D., M.P.II., referred as the PROVINCE OF GUIMARAS;

-AND-

NATIONAL PRINTING OFFICE, government agency, with principal address at EDSA Corner NIA North Road, Quezon City, Philippines, represented by DIRECTOR IV, FRANCISCO V. VALES JR., herein referred as NATIONAL PRINTING OFFICE;

WITNESSETH

WHEREAS, the NATIONAL PRINTING OFFICE, per Executive Order No. 285 dated July 25, 1987; and as amended by E.O 378 the National Printing Office (NPO) is mandated to continue to provide printing services to government agencies and instrumentalities as mandated by law especially on specialized forms such as accountable forms as per Appendix 20 of the IRR of RA 9184;

WHEREAS, the PROVINCE OF GUIMARAS, through its Provincial Treasurer's Office requested to procure 2,000 pads of accountable forms No. 51 with a total cost of P460,000.00;

WHEREAS, the PROVINCE OF GUIMARAS, through its Bids and Awards Committee recommended to GOVERNOR, HONORABLE SAMUEL T. GUMARIN, M.D., M.P.H. Head of the Procuring Entity to award the contract to NATIONAL PRINTING OFFICE as the servicing agency through the Agency to Agency mode of procurement as provided in Sec. 53.5 of Revised Implementing Rules and Regulations of Republic Act No. 9184 in relation to Appendix 20 thereof, otherwise known as the Government Procurement Reform Act per BAC Resolution No. 648 dated December 2, 2019.

NOW THEREFORE, in view of the foregoing premises, the parties herein agree on the following:

A. THE NATIONAL PRINTING OFFICE:

- To supply the Provincial Treasurer's Office of the Province of Guimaras 2,000 pads of Accountable
 Forms No. 51 (carbonless 4"x8 1/2") with security features at Php 230 /per pad per RQF No. PR
 No. 2019-08-448 Agency to Agency amounting to Four Hundred Sixty Thousand Pesos Only (P
 460,000,00);
- 2. To deliver the 2,000 pads of Accountable Forms No. 51 (carbonless 4"x8 1/2") within thirty days (30) days from execution of the Memorandum of Agreement;
- 3. Not to sub contract the said forms;

B. THE PROVINCE OF GUIMARAS:

To pay the amount of Four Hundred Sixty Thousand Pesos Only (P460,000.00) upon full delivery of the above stated forms to the Provincial Treasurer's Office, Province of Guimaras.

After the lapsed of thirty days from execution of the agreement and the delivery is incomplete, only those forms delivered shall be paid by the Province of Guimaras and the agreement shall be immediately terminated without need of court action for failure of the National Printing Office to comply with the agreement;

The Province shall cause to bid the remaining/undelivered forms thru public competitive bidding in accordance to RA 9184.

RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, National Printing Office, Provincial Treasurers Office and all other concerned offices for information and
