

RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 001, SERIES OF 2020 AUTHORIZING SUPPLEMENTAL BUDGET FISCAL YEAR 2020 FOR THE GENERAL FUND AND LOCAL ECONOMIC ENTERPRISE OF THE MUNICIPALITY OF BUENAVISTA, PROVINCE OF GUIMARAS OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 001, Series of 2020 of the Municipality of Buenavista authorizing its Supplemental Budget Fiscal Year 2020 involving an appropriation of ₱5,704,914.48 for the General Fund and ₱347,736.88 for the Local Economic Enterprise was submitted to this Body for review pursuant to the provisions of Republic Act 7160;
