GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE LIBON BAG WEAVER'S ASSOCIATION FOR THE PROVISION OF FINANCIAL ASSISTANCE IN THE AMOUNT OF ₱100,000.00 FOR THE WEAVING ENHANCEMENT LIVELIHOOD PROJECT

WHEREAS, the Honorable Governor in his letter dated March 12, 2020 is requesting for an authority to sign for and in behalf of the provincial government the Memorandum of Agreement with the Libon Bag Weaver's Association for the provision of financial assistance in the amount of PHP 100,000.00 for its Weaving Enhancement Livelihood Project;

WHEREAS, this Honorable Body interposes no objection to the request on the terms, conditions and stipulations provided in the Memorandum of Agreement presented before it and the disbursement of funds shall be in accordance with the existing accounting and auditing rules and regulations applicable;

THE PROVINCIAL GOVERNMENT OF GUIMARAS, with office address at San Miguel, Jordan, Guimaras represented herein by the Honorable **SAMUEL T. GUMARIN MD. MPH**, Provincial Governor, herein referred to as the "**FIRST PARTY**".

And

LIBON BAG WEAVER'S ASSOCIATION INC. represented by its President **CIRILA G. MIRANDA** duly registered with the Department of Labor and Employment (DOLE) under Registration No. R0605-201410-WA-002 with business address at **Barangay Calaya, Nueva Valencia, Guimaras** herein referred to as the "**SECOND PARTY**".

WITNESSETH:

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code 1991, Chapter 4, Section 36, provides that a local government unit may, through its local chief executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people and non-governmental organizations for economic, socially- oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction.

WHEREAS, the Province of Guimaras under the dynamic leadership of its Governor, Honorable Samuel T. Gumarin is committed to assist deserving people and non- governmental organizations by providing technical and financial assistance thereby helping in the upliftment of socio- economic status of members;

WHEREAS, the **LIBON BAG WEAVER'S ASSOCIATION INC** of **Barangay Calaya, Nueva Valencia** is one of the non- governmental organizations qualifies to avail of the said assistance;

WHEREAS, the Libon Bag Weaver's Association Inc. of Nueva Valencia adheres to the same aspiration and is willing to undertake and implement project guidelines for the purpose; and

WHEREAS, this partnership is vital to ensure the successful implementation of the said project and achieve its desired social and economic outcomes.


NOW THEREFORE, for the above consideration, the parties hereby agree to undertake the following complimentary activities:

1. The PROVINCE shall:
 - 1.1 Provide "Fund" in the amount of **ONE HUNDRED THOUSAND PESOS (P100, 000. 00) ONLY** as livelihood program to the **LIBON BAG WEAVER'S ASSOCIATION INC.** of Nueva Valencia for their weaving enhancement livelihood project; and
 - 1.2 Provide technical assistance in organizational, financial and project management.
2. **The Libon Bag Weaver's Association Inc of Nueva Valencia shall:**
 - 2.1. Undertake the Immediate implementation of the Livelihood Program for the Libon Bag Weaver Association as presented in the approved project proposal within one (1) year upon release of the fund by the **FIRST PARTY**;
 - 2.2. Utilize the entire amount strictly for the association's venture presented;
 - 2.3. Keep maintains separate financial records of the fund;
 - 2.4. Allow visitorial financial audit and examination of the **FIRST PARTY** through its authorized representative;
 - 2.5. Submit a liquidation report with supporting documents to the **FIRST PARTY**, relevant to the fund released/ transferred within 30 days upon completion of the project.
 - 2.6. Submit monthly or quarterly financial and physical status reports; and
 - 2.7. Refund of the disallowed amounts after financial audit.
3. **Modification/ Amendment and Affectivity**
 - 3.1 Any amendment of modification in this agreement shall be translated in writing signed by both parties and shall form part of this agreement; and
 - 3.2 The term of this agreement shall take effect immediately upon the date of signing of this **Memorandum of Agreement**.


RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, Libon Bag Weaver's Association, Inc. of Barangay Calaya, Nueva Valencia, Guimaras and all other concerned agencies for information and appropriate action.


