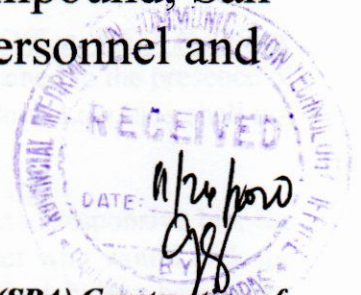

**Construction of Two Storey-Building Provincial Tourism**  
**Building (Phase 2 Package A) at Capitol Compound, San**  
**Miguel, Jordan, Guimaras with Technical Personnel and**  
**Equipment required.**

1. The Provincial Government of Guimaras, through the 2020 G.F. (SPA) Construction of 2 Story Building Provincial Tourism Office intends to apply the sum of Three Million Nine Hundred Forty-Two Thousand Twenty-Three Pesos and 13/100 (P 3,942,023.13) being the Approved Budget for the Contract (ABC) to payments under the contract for One Job Supply of Materials and Labor for the Construction of Two Storey-Building Provincial Tourism Building (Phase 2 Package A) at Capitol Compound, San Miguel, Jordan, Guimaras with Technical Personnel and Equipment required. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Provincial Government of Guimaras now invites bids for One Job Supply of Materials and Labor for the Construction of Two Storey-Building Provincial Tourism Building (Phase 2 Package A) at Capitol Compound, San Miguel, Jordan, Guimaras with Technical Personnel and Equipment required. Completion of the Works is required 180 Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from Bids and Award Committee (BAC), Secretariat Provincial Government of Guimaras and inspect the Bidding Documents at the address given below during office hours, from Monday to Friday, from 8:00 A.M. to 4:30 P.M.
5. A complete set of Bidding Documents may be acquired by interested bidders on November 24, 2020 to December 15, 2020 during office hours Monday to Friday, from 8:00 A.M. to 4:30 P.M. from the BAC Office, PEO Building, Provincial Capitol Complex, San Miguel, Jordan, Guimaras and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (P5,000.00)

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Provincial Government will conduct Pre-Bid Conference on **December 01, 2020** , 9:00 A.M. at BAC Office, PEO Building , Provincial Capitol, San Miguel, Jordan, Guimaras.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **9:00 A.M. December 15,2020**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **9:30 A.M. December 15,2020** at **BAC Office, PEO Building, Provincial Capitol, San Miguel, Jordan, Guimaras**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. In case of a tie among two or more bidders with the lowest calculated responsive bid, the winning bidder shall be chosen through draw lots. The lucky bidder who would pick the paper with a "Congratulations" remark shall be declared as the final bidder having the LCRB and recommended for award of the contract.
9. The **Provincial Government of Guimaras** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
