

The Province of Guimaras, through the General Fund intends to apply the sum of Two Hundred Forty-Nine Thousand Six Hundred Thirty -Six Pesos and 79/100 (Php 249,636.79) being the Approved Budget for the Contract (ABC) to payments under the contract for One Job Supply of Materials and Labor for the Construction of Multi-Purpose Concrete Pavement (Completion) with Basketball Post and Board with Ring at Sitio Esperanza, Balcon Maravilla, Jordan, Guimaras with technical personnel required in excess of the ABC shall be automatically rejected at bid opening.
2. The Province of Guimaras now invites bids for the above Procurement Project. Completion of the Works is required within thirty (30) calendar days upon issuance of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

A complete set of Bidding Documents may be acquired by interested bidders on **June 08, 2021 until June 16, 2021** from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos Only P 500.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees and it will be presented in person.

6. No pre-bid required.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before 9:00 A.M. June 16,2021. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on June 16,2021 at 9:30 A.M. at the given address below . Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Province of Guimaras reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
