AN ORDINANCE SUSPENDING THE IMPLEMENTATION OF ORDINANCE NO. 2020-02 ENTITLED: "AN ORDINANCE ESTABLISHING THE GUIMARAS HOSPITALS CONSIGNMENT SYSTEM AND FOR OTHER PURPOSES

Be it ordained by the 9th Sangguniang Panlalawigan of the Province of Guimaras in session duly assembled that:

Section 1. This Ordinance shall be known as an Ordinance suspending the Implementation of Ordinance No. 2020-02 entitled: "An ordinance establishing the Guimaras Hospitals Consignment System and for other purposes".
