AN ORDINANCE CREATING THE POSITION OF DENTIST I AT THE BUENAVISTA EMERGENCY HOSPITAL

Be it ordained by the 9th Sangguniang Panlalawigan of the Province of Guimaras in session assembled that:

Section 1. Title. This Ordinance shall be known as an “*Ordinance Creating the Position of Dentist I at the Plantilla of the Buenavista Emergency Hospital*”.

Section 2. Objective: To achieve the DOH Level I accreditation/License to Operate.

Section 4. Duties and Responsibilities.

Percent of Working Time	Duties and Responsibilities
40%	1. Protects, restores and maintains patient's oral health
20%	2. Performs extraction of teeth among patients/ Clients
10%	3. Diagnose and treats diseases, administers care to injuries and malformations of the teeth, oral tissues and the mouth
10%	4. Renders Dental Health Education
10%	5. Attends staff development conference and meetings
10%	6. Prepares and submits reports

Section 5. Salary Grade of the Created Position. The Salary Grade of Dentist I shall be Salary Grade 14.

Section 6. Source of Fund. Funds for the position of Dentist I will be taken from the vacant position of Medical Officer IV, Buenavista Emergency Hospital.

Section 7. Separability Clause. In the event that any provision of this ordinance or parts hereof will be declared unconstitutional, such declaration shall not affect the validity of the other provisions.

Section 8. Repealing Clause. All Ordinance inconsistent herewith are hereby repealed and amended.

Section 9. Effectivity. This ordinance shall take effect upon its approval.




