**AN ORDINANCE CREATING THE POSITION OF LOCAL DISASTER RISK REDUCTION MANAGEMENT OFFICER I (LDRRMO I) AT THE PDRRMS-GOVERNOR'S OFFICE (PDRRMS-GO)**

Be it ordained by the 9<sup>th</sup> Sangguniang Panlalawigan of the Province of Guimaras in session assembled that:

**Section 1. Title.** This ordinance shall be known as an "*Ordinance Creating the Position of Local Disaster Risk Reduction Management Officer I (LDRRMO I) at the Provincial Disaster Risk Reduction Management Section (PDRRMS-Governor's Office) (PDRRMS-GO)*";

**Section 2. Objective.** To provide an officer to handle the Operations Section of the PDRRMO in time of pandemic, focusing on the transport of COVID-19 patients and there that are contract traced;

**Section 3. Qualifications.** The qualifications are as follows:

**Section 4. Duties and Responsibilities.**

Percent of Working Time	Duties and Responsibilities
30%	1. Assists in the conduct of continuous disaster monitoring and mobilize instrumentalities and entities of the LGUs, CSOs, private groups and organized volunteers, to utilize their facilities and resources for the protection and preservation of life and properties during emergencies in accordance with existing policies and procedures
20%	2. Assists in responding to and managing the adverse effects of emergency and carry out recovery activities to the most vulnerable areas especially to the vulnerable sectors (women, children, senior citizens and PWD)
20%	3. Assists in the formulation and coordination of linkage systems for use during disaster response
20%	4. Assists in the implementation of activities of the PDRRMO
10%	5. Carry out any other assignments as tasked by his/her supervisor
100%	

**Section 5. Salary Grade of the Created Position.** The Salary Grade of LDRRMO I shall be Salary Grade 11.

**Section 6. Source of Fund.** Funds for the positions of LDRRMO I will be taken from the vacant position of Executive Assistant III, Office of the Governor.

**Section 7. Separability Clause.** In the event that any provision of this ordinance or parts hereof will be declared unconstitutional, such declaration shall not affect the validity of the other provisions.

**Section 8. Repealing Clause.** All Ordinance inconsistent herewith are hereby repealed and amended.

**Section 9. Effectivity.** This ordinance shall take effect upon its approval.
