ORDINANCE NO. 2022-04

AN ORDINANCE SUSPENDING CERTAIN PROVISIONS OF ORDINANCE NO. 2020-04, SERIES OF 2020, ENTITLED: AN ORDINANCE PRESCRIBING FOR MEASURES AND POLICIES AGAINST EMERGING AND RE-EMERGING INFECTIOUS DISEASES IN THE PROVINCE THEREBY ESTABLISHING THE "NEW NORMAL" IN CONNECTION THEREWITH

Be it enacted by the 9th Sangguniang Panlalawigan in session duly assembled, that:

Section 1. The effectivity of the implementation of Inbound Pass and Outbound Resident Pass as defined and mandated by Sections 3.5 and 3.9 in relation to Sections 5 and 6 of Provincial Ordinance No. 2020-04 entitled: *"An Ordinance prescribing for measures and policies against emerging and re-emerging infectious diseases in the province thereby establishing the "new normal" in connection therewith"* is hereby suspended. Upon prior notice to the Sangguniang Panlalawigan, the Governor is hereto authorized to reimpose the effectivity of the implementation of Inbound Pass and Outbound Resident Pass should public health and interest so require.

Section 2. Separability Clause. If any part or provision of this Ordinance shall be declared unconstitutional or unlawful by the court, all other provisions not otherwise affected thereby shall remain valid and effective.

Section 3. Repealing Clause. Any Ordinance contrary or inconsistent with any provisions of this Ordinance is hereby repealed, amended or modified accordingly.
