AN ORDINANCE MODIFYING THE POLICY IN THE IMPLEMENTATION OF HEALTH DECLARATION CARDS AS PER PROVINCIAL ORDINANCE NO. 2020-04, SERIES OF 2020, ENTITLED: AN ORDINANCE PRESCRIBING FOR MEASURES AND POLICIES AGAINST EMERGING AND RE-EMERGING INFECTIOUS DISEASES IN THE PROVINCE THEREBY ESTABLISHING THE "NEW NORMAL" IN CONNECTION THEREWITH

Be it enacted by the 10th Sangguniang Panlalawigan in session duly assembled, that:

Section 1. In the interest of health and public interest, the Provincial Governor is hereby authorized through an Executive Order issued for the purpose, to effect any modifications, alterations, changes to and even suspend the implementation of Health Declaration Cards as mandated by sections 5, 5.1 and 5.2 in relation to section 3.3 of Provincial Ordinance No. 2020-04, Series of 2020 entitled "An Ordinance prescribing for measures and policies against emerging and re-emerging infectious diseases in the province thereby establishing the "new normal" in connection therewith".

Section 2. Separability Clause. If any part or provision of this Ordinance shall be declared unconstitutional or unlawful by the court, all other provisions not otherwise affected thereby shall remain valid and effective.




