ORDINANCE NO. 2022-10

AN ORDINANCE AMENDING SECTION 7 OF PROVINCIAL ORDINANCE NO. 2020-04, SERIES OF 2020, ENTITLED: AN ORDINANCE PRESCRIBING FOR MEASURES AND POLICIES AGAINST EMERGING AND RE-EMERGING INFECTIOUS DISEASES IN THE PROVINCE THEREBY ESTABLISHING THE "NEW NORMAL" IN CONNECTION THEREWITH

Be it enacted by the 10th Sangguniang Panlalawigan in session duly assembled, that:

Section 1. Section 7 of Provincial Ordinance No. 2020-04, Series of 2020 is hereby amended as follows:

Section 7. MANDATORY WEARING OF FACE MASKS. All persons shall be required to properly wear masks while in public places at all times.

7.1. It shall be prohibited for any adult/guardian in the company of the minor who, while in a public place or workplace tolerates, permits or allows the said minor not to wear face mask;

7.2. It shall likewise be prohibited for any person who shall induce, influence or coerce, personally or through any social media platform, a person not to wear face mask;

7.3. Subject to any applicable issuances that may be promulgated by the National Government on the wearing of face masks, wearing of face masks in non-crowded open spaces and outdoor areas with good ventilation shall be voluntary.

However, individuals who are not fully-vaccinated, senior citizens and immunocompromised individuals are highly encouraged to wear their masks. Physical distancing shall be observed at all times.

For this purpose, open space or outdoor areas shall refer to areas outside the building, structure or improvement.

Section 2. Separability Clause. If any part or provision of the Ordinance shall be declared unconstitutional or unlawful by the court, all other provisions not otherwise affected thereby shall remain valid and effective.

Section 3. Repealing Clause. Any Ordinance contrary or inconsistent with any provisions of this Ordinance is hereby repealed, amended or modified accordingly.

Section 4. Effectivity. This Ordinance shall take effect immediately.


