ORDINANCE NO. 2022-12

AN ORDINANCE STRENGTHENING THE PROVINCIAL ECONOMIC DEVELOPMENT OFFICE (PEDO) OF THE PROVINCIAL GOVERNMENT OF GUIMARAS THEREBY AMENDING PROVINCIAL ORDINANCE NO. 2019-05 ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE PROVINCIAL ECONOMIC DEVELOPMENT OFFICE IN THE PROVINCE OF GUIMARAS"

Be it enacted by the Sangguniang Panlalawigan of the Province of Guimaras in session duly assembled, that:

Section 1. This ordinance shall be known as "An Ordinance Strengthening the Provincial Economic Development Office of the Provincial Government of Guimaras".

Section 2. Functions and Objectives

The primary planning, programming, coordinating, implementing and evaluating economic development and tourism industry promotion and in coordination with the private sector groups, national government agencies and other government instrumentalities to generate employment, investment and support the revenue generation activities of the local government units.

The specific functions are the following:

1. Promote province as investment destination and assisting in the growth and development of the province's agribusiness, fishery and tourism sector;
2. Develop and implement economic related information database for decision of policy makers, investors, entrepreneurs and municipal LGUs;
3. Develop and strengthen cooperatives, farmers/fisher folks, community-based rural organizations and tourism associations, and providing livelihood and entrepreneurial management services;

4. Develop and market agri-eco tourism circuits by showcasing agri-fishery and eco-tourism products and services; creating tourism marketing campaigns, and supporting and implement tourism events and activities; and
5. Provide multi-employment facility and services to jobseekers and youths in order to find stable and sustainable employment to support the agri-fishery and tourism activities and other related areas.

Section 3. The PEDO shall consist of the following sections:

- a. Tourism Section;
- b. Trade and Investment Section;
- c. Cooperative Development Section; and
- d. Labor and Employment Services Section;

Section 4. The Provincial Tourism Office created under Provincial Ordinance No. 2012-006 is hereby converted into a Tourism Section mentioned in the immediately preceding section.

Section 5. To complement the provisions of section 3 hereof, a Labor and Employment Services Section with the corresponding staff as reflected in the PEDO Organizational Structure is hereby created.

Section 6. The organizational structure of the PEDO is reflected in Annex "A" hereof and shall form part of this ordinance.

Section 7. The description of the positions under the PEDO is reflected in Annex "B" hereof and shall form part of this ordinance.

Section 8. Separability Clause. If any portion or provision of this ordinance is declared unconstitutional, the remainder of this ordinance or any provision not affected thereby shall remain in force and effect.

Section 9. Repealing Clause. All ordinances inconsistent herewith are hereby repealed or amended.

Section 10. Effectivity Clause. This Ordinance shall take effect upon its approval.


