RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE BARANGAY COUNCIL OF MABINI, BUENAVISTA, GUIMARAS FOR THE RELEASE OF THE AMOUNT OF ₱100,000.00 AS FINANCIAL ASSISTANCE FOR QUALIFYING IN THE 3GSB EVALUATION

WHEREAS, the Provincial Government of Guimaras had established the Guimaras Good Governance Seal for Barangays (3GSB) with the aim of promoting excellence in barangay governance;

WHEREAS, the evaluation and conferment of the Seal was conducted by the provincial government in coordination with DILG; the qualified barangay shall be given an incentive fund in the amount of ₱100,000.00 to fund development projects of the concerned barangay;

WHEREAS, the Honorable Governor, in his letter dated March 8, 2019, requested for an authority to sign for and in behalf of the provincial government the Memorandum of Agreement with the Barangay Council of Barangay Mabini, Buenavista, said Memorandum of Agreement specifies the terms and conditions for the release of the amount of ₱100,000.00 as financial assistance by way of an incentive for having qualified in the 3GSB to be used for the purchase of Computer with Printer, 2 Units Computer and Installations of 3pcs, Computer Tables;

WHEREAS, this Honorable Body interposes no objection on the request on the terms, conditions and stipulations provided in the Memorandum of Agreement presented before it and the disbursement of funds shall be in accordance with the existing accounting and auditing rules and regulations applicable;

NOW THEREFORE, on motion of Honorable David G. Gano, Chairperson, Committee on Appropriations, duly seconded by Honorable Cyril C. Beltran, Honorable Diosdado G. Gonzaga, Honorable Aurelio G. Tionado and Honorable Ma. Sheila G. Gange;

THE 8TH SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to authorize Gov. Samuel T. Gumarin, MD, MPH to sign for and in behalf of the provincial government the following:

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is entered into this ____ day of ____ 2019 at the Provincial Capitol, Province of Guimaras by and between:

The Provincial Government of Guimaras, a local government unit established under existing laws of the Republic of the Philippines, with principal address at the Provincial Capitol, Brgy. San Miguel, Jordan, Guimaras, represented herein by the Provincial Governor, the **HON. SAMUEL T. GUMARIN, MD, MPH** hereinafter referred to as the First Party;

-and-

The Barangay Council of Barangay Mabini, a local government unit established under existing laws of the Republic of the Philippines, with principal address at Mabini, Buenavista, Guimaras, represented herein by the Punong Barangay, the **HON. SALVACION E. FERRER**, hereinafter referred to as the Second Party;

WITNESSETH

WHEREAS, The Seal of Good Local Governance (SGLG) is a scaled up "Seal of Good Housekeeping" awarded by the Department of the Interior and Local Government (DILG) to recognize the good performance of the provincial, city and municipal governments not only on housekeeping but also on other areas that directly benefit the people;

WHEREAS, the SGLG does not cover the barangays, being the basic political unit and the primary planning and implementing unit of government plans, programs, projects and activities in the community;

WHEREAS, there are more than forty two thousand (42,000) barangays and the DILG does not have enough manpower and resources to cope with the assessment and evaluation;

WHEREAS, the Provincial Government of Guimaras established the Guimaras Good Governance Seal for Barangays (3GSB) to promote excellence in barangay governance;

WHEREAS, the barangays must be strengthened and challenged to sustain the practice of transparency and accountability in the use of public funds, prepare for the challenges of disasters, protect constituents from threats to life and security and safeguards the integrity of the environment among others;

WHEREAS, the evaluation and conferment of the Seal along with the provision of an incentive fund to qualified barangays was implemented by the Provincial Government of Guimaras in coordination with DILG Guimaras;

WHEREAS, the qualified barangay was given One Hundred Thousand Pesos (₱100,000.00) as incentive fund for having complied with the requirements of the Seal;

WHEREAS, the qualified barangay shall submit a project proposal of its developmental project to the Office of the Governor for the approval and release of the incentive fund;

WHEREAS, an agreement must be forged between the Provincial Government of Guimaras and the Barangay Council of Barangay Mabini for the proper utilization of the incentive fund aligned with their project proposal as per requirement of the Commission on Audit;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto have agreed to enter into this Memorandum of Agreement under the following terms and conditions:

1.0 The PROVINCE shall:

- 1.1 Release the incentive fund in the amount of **One Hundred Thousand Pesos (₱100,000.00)** to the SECOND PARTY for having qualified in the 3GSB evaluation upon submission of the complete documentary requirements;
- 1.2 Ensure the compliance of documentary requirements from the SECOND PARTY for the liquidation of the fund transferred.

2.0 The BARANGAY COUNCIL OF BARANGAY MABINI shall:

- 2.1 Submit a letter of intent/request, project proposal, program of works, barangay resolution requesting for the release of the incentive fund and barangay resolution authorizing the Punong Barangay to enter into agreement with the FIRST PARTY;
- 2.2 Undertake the immediate implementation of the project as represented in the approved project proposal upon release of fund by the FIRST PARTY;
- 2.3 Submit a liquidation report with supporting documents to the FIRST PARTY, relevant to the fund released/transferred upon completion of the project; and
- 2.4 Abide with the auditing rules and regulations relevant to this matter.

3.0 Modification/Amendment and Effectivity


- 3.1 Any amendment or modification in this agreement shall be translated in writing signed by both parties and shall form part of this agreement; and
- 3.2 The term of this agreement shall take effect immediately upon the date of signing of the **Memorandum of Agreement**.

RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor; Barangay Council of Barangay Mabini, Buenavista and all other concerned agencies for information and appropriate action.
