#### MEMORANDUM OF AGREEMENT

This AGREEMENT made and entered into this \_\_\_ day of \_\_\_ 2019 by and between:

HON. SAMUEL T. GUMARIN, MD MPH, with address at PROVINCIAL CAPITOL BUILDING, SAN MIGUEL, JORDAN, GUIMARAS, representing the PROVINCE OF GUIMARAS hereinafter referred to as the FIRST PARTY.

and

ULTRA COMBO represented by MR. DENNIS J. CAYUDITAN, with address at DOOR 9 YUSAY-PEREZ APARTMENT 14 AGUINALDO STREET, BACOLOD CITY, NEGROS OCCIDENTAL 6100 hereinafter referred to as SECOND PARTY.

WITNESSETH that :

Whereas, the FIRST PARTY agreed to engage the services of ULTRA COMBO in one show only with the following detail:

EVENT : MANGGAHAN FESTIVAL 2019  
 PROVINCE OF GUIMARAS  
 VENUE : PROVINCIAL CAPITOL GROUNDS  
 DATE : MAY 22, 2019

Now, therefore the FIRST PARTY and the SECOND PARTY by these present do hereby enter into this Agreement whereby the FIRST PARTY engages the services of the SECOND PARTY under the following terms and conditions :

01. SECOND PARTY shall provide the following :
  - a. Performance for 45 minutes Standard Set
  - b. Instruments such as bass guitar, lead guitar, drum sticks and other needed instruments;
  - c. CD or USB in MP3 format
02. The SECOND PARTY guarantees the complete appearance and performance of the Band in one show in consideration of :
  - a. THREE HUNDRED SEVENTY THOUSAND PESOS (Php 370,000.00) ONLY as Talent Fee
  - b. Payable by the FIRST PARTY in CASH
    - 50% Down Payment amounting to Php 185,000.00 ONLY
    - 50% Full Payment amounting to Php 185,000.00 before the show starts
03. The FIRST PARTY shall provide the following for the band :
  - a. Airfare. Round-trip ticket with 20 kilos baggage allowance per person per way
  - b. Hotel accommodation
  - c. Said venue should be rain proof with stage, electrical supply and back drop for the performance
  - d. Technical requirements to follow
  - e. Ample security to safeguard the well-being of the band
  - f. Food and drinks for the band and its entourage (no pack meals)
  - g. Unlimited mineral water for the band during their performance on stage
04. This Contract deemed valid and effective only upon receipt of the signed contract and shall be deemed terminated immediately after the Band has rendered.
05. In the event the FIRST PARTY cancels the engagement or is unable to perform its obligations under this contract for reason not attributable to the Band and provided that the reasons for the cancellation are not considered fortuitous events or acts of God, the FIRST PARTY forfeits to the SECOND PARTY any and all payments already made.


- 06. The SECOND PARTY agrees that the Band will perform their best ability expected of the professional Band to the performance or services to be rendered. The Band agrees to refrain from using foul or obscene languages during performance;
- 07. That in case the engagement is cancelled by reasons or as a consequences of fortuitous events or acts of God, or other acts thought unforeseen, and cannot be reasonably prepared for the parties. Both parties shall agree to a renewed date that shall in no cause be more than thirty (30) days from the date of original engagement. The parties shall exercise utmost obligate and good faith in fixing the date of engagement with due regard to the schedule of the artist and the purposed of the FIRST PARTY in holding the engagement.

RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, Ultra Combo, Mr. Dennis J. Cayuditan and all other concerned offices for information and appropriate action.
