WHEREAS, Appropriation Ordinance No. 2018-4, Series of 2018 of the Municipality of San Lorenzo authorizing its Annual Executive Budget for Calendar Year 2019 involving an appropriation of ₱102,121,861.75 was submitted to this Body for review pursuant to the provisions of Republic Act 7160;

WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations and may therefore be considered operative as of the date fixed in the Appropriation Ordinance, subject however to some conditions;

RESOLVED, to declare Appropriation Ordinance No. 2018-4, Series of 2018 authorizing the Annual Executive Budget, Calendar Year 2019 for the General Fund of the Municipality of San Lorenzo, Province of Guimaras operative in its entirety effective as of the date fixed in Appropriation Ordinance No. 2018-4, Series of 2018 subject to the posting requirements under Section 59 of R.A. 7160 and subject further to the following conditions:

1. The Municipality of San Lorenzo shall only utilize the amount being authorized in the Appropriation Ordinance pursuant to Section 319 of RA 7160.
2. It is hereby recommended that lacking amount provided for the Senior Citizens and PWD will be appropriated in the succeeding Supplemental Budget of the Municipality.
3. The appropriation in the Annual Executive Budget of the Municipality is hereby recommended to be declared operative for it shows compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations subject to the following guidelines:
 - a. The 5% LDRRM utilization shall be in accordance with the IRR of RA 10121, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Circular No. 2012-1 dated March 25, 2013. Further the Municipality LDRRMF must be reviewed by the office of the Civil Defense.
 - b. 20% Development Fund Municipality approved Annual Investment Plan and DILG-DBM Joint Circular No. 2017-1 dated February 27, 2017.
 - c. 4th Tranche Salary Increase Implementation-Local Budget Circular No. 118 dated January 15, 2019.
 - d. Intelligence/Confidential Expenses-COA DBM-GCD-DND-JMC No. 2015-01 dated January 15, 2019.
 - e. GAD Plan, Local Budget Memorandum No. 77 dated May 15, 2018 shall be endorsed by the DILG.
 - f. Nutrition Action Plan-DILG Memorandum Circular No. 2018-42 dated March 26, 2018 must be formulated in the Philippine plan of Action for Nutrition covering the period 2017-2020.

RESOLVED FURTHER, to inform the Municipality of San Lorenzo that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of the law.

RESOLVED FINALLY, to send a copy of this resolution to the Sangguniang Bayan, Municipal Mayor, all in the Municipality of San Lorenzo for information.
