RESOLUTION AUTHORIZING GOVERNOR SAMUEL T. GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE JORDAN DISTRICT JAIL FOR THE RELEASE OF FINANCIAL ASSISTANCE FOR THE DIGGING OF DEEPWELL

WHEREAS, the Honorable Governor in his letter dated March 20, 2019 is requesting for an authority to sign for and in behalf of the provincial government the Memorandum of Agreement with the Jordan District Jail for the release of financial assistance in the amount of ₱78,610.00 for the digging of deep well at the Jordan District Jail, Barangay Alaguissoc, Jordan, Guimaras;

WHEREAS, this Honorable Body recognizing the need for water of the Jordan District Jail, interposes no objection to the request, subject to the terms, conditions and stipulations set forth in the draft Memorandum of Agreement presented before it and disbursement of funds shall be in accordance with existing accounting and auditing rules and procedures;

RESOLVED, to authorize Governor Samuel T. Gumarin, MD, MPH to sign for and in behalf of the Provincial Government of Guimaras the following:

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

The foregoing Memorandum of Agreement is entered into by and between the Province of Guimaras represented by its Governor, Hon. Samuel T. Gumarin, M.D., M.P.H. as the First Party and the Jordan District Jail, a government institution in charge with the jail facilities and as well as the inmates and persons deprived of liberty represented by SINSIP. Carlito B. Barrera, of legal age, Filipino with office address at Jordan District Jail, Brgy Alaguisoc, Jordan, Guimaras as the Second Party;

WITNESSETH

Whereas, the second party is currently securing 99 inmates coming from the five (5) Municipalities of the Province of Guimaras;

Whereas, the second party is concerned of the safety and security of the inmates and realizes the water shortage in the said institution as a threat to the inmates and the personnel of the institution;

Whereas, the first party recognizes the role of the second party to the Local Government Units and is aware of the needs of the second party especially with water;

Whereas, the second party proposes the digging of a deep well in the said institution to answer the water shortage crisis;


Whereas, the first party realizing the needs of the second party agrees to extend financial assistance to the latter in the amount of SEVENTY EIGHT THOUSAND SIX HUNDRED TEN PESOS (₱78,610,00.) for the said project subject to liquidation and in accordance with the usual auditing and accounting rules and regulations.

RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, Jordan District Jail, and all other concerned offices for information and appropriate action.
