GUMARIN, MD, MPH TO SIGN FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT THE MEMORANDUM OF AGREEMENT WITH THE MUNICIPALITY OF SAN LORENZO, THIS PROVINCE FOR THE GRANT OF FINANCIAL ASSISTANCE FOR THE PARTICIPATION OF THAT MUNICIPALITY IN THE CULTURAL COMPETITION IN CONNECTION WITH THE 26TH MANGGAHAN FESTIVAL AND 27TH ANNIVERSARY CELEBRATION OF THIS PROVINCE

WHEREAS, the Honorable Governor in his letter dated March 26, 2018, is requesting for an authority to sign for and in behalf of the Provincial Government the Memorandum of Agreement with the Municipality of San Lorenzo for the grant of financial assistance in the amount of ₱200,000.00 for the participation of that municipality in the Cultural Competition in connection with the 26th Manggahan Festival and 27th Anniversary Celebration of this province;

WHEREAS, this Honorable Body interposes no objection to the request, subject to the terms, conditions and stipulations set forth in the draft Memorandum of Agreement presented before it and disbursement of funds shall be subject to the usual accounting and auditing procedures;

RESOLVED, to authorize Governor Samuel T. Gumarin, MD, MPH to sign for and in behalf of the Provincial Government of Guimaras the following:

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement entered by and between:

The Provincial Government of Guimaras represented by **HON. SAMUEL T. GUMARIN, MD, MPH**, with office address at San Miguel, Jordan, Guimaras, Philippines referred hereinafter as the **FIRST PARTY**;

and

The Municipality of San Lorenzo represented by **HON. NINFA G. GAJO** with office address at Cabano, San Lorenzo, Guimaras, Philippines referred hereinafter as the **SECOND PARTY**;

WITNESSETH:

WHEREAS, the Provincial Government of Guimaras (PGG) will be celebrating its 2019 Manggahan Festival and 27th Anniversary Celebration of Provincehood with a theme "*Matam-is nga Kadalag-an: Manggahan Festival to the World*" a month-long provincewide annual celebration.

WHEREAS, the PGG takes initiative spearheading activities that will enrich and promote the culture and history of the province such as the Cultural Presentation.

WHEREAS, the in support to the festival of the Province, municipalities participate in the Cultural Competition by endorsing one Hubon entry, a cultural group that will present the culture and traditions of the municipality through dance.

WHEREAS, the Cultural Competition is scheduled in the afternoon of May 22, 2019 as the highlight of the grand celebration of the 2019 Manggahan Festival.

WHEREAS, The **FIRST PARTY** which is the Provincial Government of Guimaras (PGG):

- Provides and downloads the financial assistance to the **SECOND PARTY** to be used for the activities of Cultural Presentation amounting to Php 200,000.00 per competing Hubon.
- Facilitates the conduct of meetings for the finalization of Rules and Guidelines, schedule of festival monitoring and assessment, blocking and other concerns regarding the Cultural Competition.
- Conducts monitoring and assessment with the respective Manggahan Working Committee on the Cultural Competition.
- Requires the municipality to provide a copy of liquidation not later than one month after the conduct of the Cultural Competition.

WHEREAS, The **SECOND PARTY** which is the Municipality of San Lorenzo, Guimaras will:

- Identify activities and submit proposal according to the allocated budget by the **FIRST PARTY** related to Cultural Competition as basis for the issuance of Authority by the Sangguniang Panlalawigan to the governor to release such amount.
- Identifies and endorse participants of Hubon to represent the municipality to the 2019 Manggahan Festival Cultural Competition.

- Coordinates with the Hubon on the schedule of festival monitoring and assessment, blocking and other concerns regarding the competition.
- Oversees and monitors the management of funds and resources of their respective activities.
- Comply with the requirements of Section 3.1.3 of COA Circular 2012-001, particularly on the required liquidation of fund transfer to include submission of the following to the Provincial Government.
 - a. Report of Checks Issued and Report of Disbursements certified correct by the Municipal Accountant, approved by Municipal Mayor, and duly audited by the Auditor of the Municipal Government.
 - b. Copy of Credit Notice issued by the Auditor of the Municipal Government; and
 - c. Copy of OR issued for the refund of unexpended/unutilized balance of fund transfer.


This Memorandum of Agreement contains the complete understanding of the parties and may not be amended or modified except through another agreement in writing duly executed by all parties.


RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, Honorable Mayor, Municipality of San Lorenzo and all other concerned offices for information and appropriate action.
