RESOLUTION APPROVING THE CONTRACT AGREEMENT FOR ONE (1) JOB SUPPLY OF MATERIALS AND LABOR FOR THE CONSTRUCTION OF GUIMARAS GOVERNANCE CENTER WITH THE CONTRACT PRICE OF ₱276, 196, 086. 86

WHEREAS, the provincial government has an approved loan with Land Bank of the Philippines in the amount of ₱300,000,000.00 to fund the Construction of the Guimaras Governance Center;

WHEREAS, the Honorable Governor in his letter dated March 26, 2019 is requesting for this Honorable Body's approval of the Contract Agreement Form for One (1) Job Supply of Materials and Labor for the Construction of the Guimaras Governance Center with the contract price of ₱276, 196, 086. 86 as imposed by the Land Bank of the Philippines;

WHEREAS, this Honorable Body interposes no objection to the request, subject to the terms and conditions set forth in the draft Contract Agreement presented before it and disbursement of funds shall be in accordance with applicable laws, rules, regulations and the usual accounting and auditing procedures;

Contract Agreement Form

THIS AGREEMENT, made this _____ day of _____, between the PROVINCE OF GUIMARAS OF THE REPUBLIC OF THE PHILIPPINES (hereinafter called the "Entity") and E.M CUERPO/I.E. TICO CO., INC. JOINT VENTURE (JV) AT RIZAL, JORDAN, GUIMARAS (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute in PR # 2019-02-099 of ONE (1) JOB SUPPLY OF MATERIALS AND LABOR FOR THE CONSTRUCTION OF GUIMARAS GOVERNANCE CENTER AT CAPITOL COMPOUND, SAN MIGUEL, JORDAN, GUIMARAS and the Entity has accepted the Bid TWO HUNDRED SEVENTY SIX MILLION ONE HUNDRED NINETY SIX THOUSAND EIGHTY SIX PESOS & 86/100 ONLY (=P=276,196,086.86) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Apply for Eligibility and to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Credit line issued by a licensed bank, if any;
 - (l) Notice of Award of Contract and the Bidder's conforme thereto;
 - (m) Other contract documents that may be required by existing laws and/or the Entity.
 - (i) Environmental Management Plan;
 - (ii) Environmental Compliance Certificate, if applicable

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.

RESOLVED FURTHER, to send a copy of this resolution to the Honorable Governor, Land Bank of the Philippines and all other concerned offices for information and appropriate action.
