RESOLUTION STRONGLY ENDORSING TO MARITIME INDUSTRY AUTHORITY (MARINA) THE APPLICATION OF MOTORBANCA VESSELS, OPERATORS AND ASSOCIATIONS PLYING THE ROUTE ILOILO-GUIMARAS AND VICE VERSA FOR A SPECIAL PERMIT TO OPERATE AND NAVIGATE BEYOND 10 O’CLOCK IN THE EVENING EFFECTIVE APRIL 1, 2019

WHEREAS, the Motorbanca associations in the Province of Guimaras plying the route Iloilo-Guimaras vice versa has an approved Certificate of Public Convenience (CPC) issued by Maritime Industry Authority (MARINA), granting them night time navigation until 10 o’clock in the evening;

WHEREAS, the people and the Province of Guimaras are now all set for 27th Provincehood and 26th Manggahan Festival which will kick off in the first week of April 2019 and will culminate in May 2019;

WHEREAS, in preparation for the upcoming Manggahan Festival there is a necessity to extend the navigation time of motorbanca traversing the route Iloilo-Guimaras vice versa thru special trips, to quell the volume of passengers as well as celebrity performers who will participate in the said event;

WHEREAS, the Motorbanca associations have signified their intention to submit an application for a special permit to operate and navigate beyond 10 o’clock in the evening to accommodate the passengers plying the route Iloilo-Guimaras vice versa;

THE 8th SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:


