RESOLUTION FERVENTLY REQUESTING THE MARITIME INDUSTRY AUTHORITY (MARINA) THRU ITS OFFICER-IN-CHARGE/ADMINISTRATOR VADM NARCISO A. VINGSON, JR. TO ALLOW THE MOTOR PUMPBATS PLYING THE ROUTE ILOILO-GUIMARAS VICE VERSA TO OPERATE AND NAVIGATE BEYOND 10 O’CLOCK IN THE EVENING ON SPECIAL TRIPS THEREBY AMENDING THE CERTIFICATE OF PUBLIC CONVENIENCE (CPC) ON THE SCHEDULED OPERATION OF VESSELS

WHEREAS, it was observed that there was an increase in the number of passengers who travel beyond 10 o’clock in the evening plying the route Iloilo-Guimaras vice versa due to inevitable circumstances and emergency situations;

WHEREAS, the thrust of the Province as an agri-ecotourism capital of Western Visayas also contribute to the influx of tourists who, most of the time, depart the Province beyond 10:00 o’clock in the evening on a special or chartered trip of vessels;

WHEREAS, in response to the prevailing conditions, it is imperative to extend the navigation time of motorbancas by means of special or chartered trip to accommodate the passengers cruising the route Iloilo-Guimaras vice versa beyond 10 o’clock in the evening;

WHEREAS, the Motorbanca associations have previously manifested their intent to apply for the amendment of their Certificate of Public Convenience (CPC) extending the schedule of operation of vessels beyond 10 o’clock in the evening via special trips;

WHEREAS, the MARINA thru its Administrator is fervently requested to grant the proposed amendment to the Certificate of Convenience of Motorbanca associations to extend their night time navigation via special trip plying the route Iloilo-Guimaras and vice versa;
